Human Rights – “Clean, Healthy, Sustainable Environment

[With 161 Votes in Favour, 8 Abstentions, General Assembly Adopts Landmark Resolution Recognizing Clean, Healthy, Sustainable Environment as Human Right](#)

With 161 votes in favour and 8 abstentions, the General Assembly adopted a landmark resolution today recognizing the right to a clean, healthy and sustainable environment as a human right and calling for greater global efforts to ensure that principle is upheld.

Affirming that promoting that right requires the full implementation of the multilateral environmental agreements, the **193-member body called upon States, international organizations, business enterprises and other relevant stakeholders to adopt policies, enhance international cooperation, strengthen capacity-building and continue to share good practices in order to scale up efforts to ensure a clean, healthy and sustainable environment for all.**

The representative of Costa Rica, introducing the text, underscored that with the world facing an unprecedented triple environmental crisis — of climate change, biodiversity loss and pollution — the universal recognition of the human right to a clean, healthy and sustainable environment provides a powerful, effective response that could catalyse transformative changes in societies.

Prior to the text’s adoption, several delegates stressed that there is no common internationally agreed understanding on the content and scope for the right to a clean, healthy and sustainable environment, with the Russian Federation’s representative stressing that States can only talk about a legally recognized right after such right is recognized exclusively within international treaties...

The following statement was issued today by the Spokesman for UN Secretary-General António Guterres:

The Secretary-General welcomes the adoption by the General Assembly of its historic resolution recognizing the right to a clean, healthy and sustainable environment.

This landmark development demonstrates that Member States can come together in our collective fight against the triple planetary crises of climate change, biodiversity loss, and pollution. The international community has given universal recognition to this right and brought us closer to making it a reality for all.

The resolution will help reduce environmental injustices, close protection gaps and empower people, especially those that are in vulnerable situations, including environmental human rights defenders, children, youth, women and indigenous peoples. The resolution will also help States accelerate the implementation of their environmental and human rights obligations and commitments.

However, the adoption of the resolution is only the beginning. The Secretary-General urges States to make the right to a clean, healthy and sustainable environment a reality for everyone, everywhere.

Nicaragua – Civil Society

[Nicaragua: UN experts denounce arbitrary shutdown of civil society organisations](#)

GENEVA (29 July 2022) – The arbitrary shutdown of hundreds of civil society organisations in Nicaragua is deeply concerning and would have a chilling effect on activists and human rights defenders across the country, UN experts* warned today.

In a letter (*) addressed to the Nicaraguan Government on Monday, UN experts said the cancellation of the legal personality of hundreds of associations “represents a clear pattern of repressing civic space.”

The experts echoed a [statement](#) by the UN High Commissioner for Human Rights earlier this year regarding the crackdown on civil society in Nicaragua.

They expressed shock about the wide extent of the shutdowns by the National Assembly at the request of the Government. They counted the closure of more than 700 organisations, 487 of them only in the past month.

Even though the closure of civic space has been observed since the political unrest in 2018, the closure of organisations has accelerated as a result of a 2020 Law on Foreign Agents and a 2022 Law on Regulation and Control of Non-Profit Organizations (NPO), which was recently enforced.

Ahead of the NPO Law entering into force in May, the experts provided their [legal analysis](#) and expressed their concerns. Specifically, the NPO Law imposes burdensome administrative and registration procedures, the disclosure of data of beneficiaries, and significantly restricts foreign funding. To date, the experts have not received a response to their observations.

“We regret to see that, once again, counter-terrorism and anti-money laundering legislation is being misused to unnecessarily and disproportionately restrict the activities of civil society and fundamental freedoms,” the experts said, pointing to a global trend.

They said the shutdowns have not only affected human rights organisations, including those working towards the rights of women and indigenous people, but also those that promote democratic values and counter the negative effects of climate change.

The shutdowns also impact associations that provide humanitarian aid and medical services as well as educational, cultural and artistic institutions, and religious foundations.

“This situation will have even more devastating consequences for marginalised individuals and groups who rely on those services for their survival, for instance, rural and indigenous communities, children and youth, women, migrants and asylum seekers,” the experts said.

The UN experts expressed concern about the deterring effect that these shutdowns have on members of civil society. Hundreds of activists have already fled the country and sought refuge in neighbouring States due to fear of reprisals, they said.

“We urge the State to abstain from further closures and immediately reverse these severe restrictions on associations. A functioning, well-established and diverse civic and political space is key in any democratic country,” the experts said.

“Children on the Move”

Guiding Principles for Children on the Move in the Context of Climate Change

Recommendations for safeguarding the rights and well-being of children regardless of their location or migration status



Highlights

There is currently no global policy framework for addressing the needs and rights of children moving in the context of climate change. Where child-related migration policies do exist, they do not consider climate and environmental factors, and where climate change policies exist they usually overlook children’s needs.

The Guiding Principles have been developed to safeguard the rights and well-being of children moving in the context of climate change, and are as follows:

- Principle 1: Rights-based approach
- Principle 2: Best interests of the child
- Principle 3: Accountability
- Principle 4: Awareness and participation in decision-making
- Principle 5: Family unity
- Principle 6: Protection, safety and security
- Principle 7: Access to education, health care and social services
- Principle 8: Non-discrimination
- Principle 9: Nationality



These Guiding Principles are intended to be used by local and national governments, international organizations and civil society groups working with children on the move in the context of climate change. They are based on existing international law as well as operational guidelines or frameworks which have been developed by a variety of stakeholders. The Principles are derived from the Convention on the Rights of the Child, and do not create new international legal obligations.

[New guidelines provide first global policy framework on protecting children on the move in face of climate change](#)

GENEVA/NEW YORK/WASHINGTON, 25 July 2022 – The United Nations Children's Fund (UNICEF), the International Organization for Migration (IOM), Georgetown University, and the United Nations University have today launched new guidelines to provide the first-ever global policy framework that will help protect, include, and empower children on the move in the context of climate change.

The Guiding Principles for Children on the Move in the Context of Climate Change provides a set of 9 principles that address the unique and layered vulnerabilities of children on the move both internally and across borders as a result of the adverse impacts of climate change. Currently, most child-related migration policies do not consider climate and environmental factors, while most climate change policies overlook the unique needs of children.

The guidelines note that climate change is intersecting with existing environmental, social, political, economic, and demographic conditions contributing to people's decisions to move. In 2020 alone, nearly 10 million children were displaced in the aftermath of weather-related shocks. With around one billion children – nearly half of the world's 2.2 billion children – living in 33 countries at high risk of the impacts of climate change, millions more children could be on the move in the coming years.

Developed in collaboration with young climate and migration activists, academics, experts, policymakers, practitioners, and UN agencies, the guiding principles are based on the globally ratified Convention on the Rights of the Child and are further informed by existing operational guidelines and frameworks...

[Voices of the displaced: A qualitative study of potentially traumatising and protective experiences faced by refugee children](#)

Abstract

Refugee children experience potentially traumatic events that are distinct from the general population, yet current Adverse Childhood Experience (ACE) research addressing these specific adversities is scarce. This study uses qualitative interviews to identify potentially traumatising and protective experiences subjectively perceived as having an effect on the wellbeing of refugee children. Semi-structured interviews with 47 refugee parents and 11 children (aged 8-17) were conducted between November 2018 and January 2020 in the Rhine-Neckar region in Germany. Sampling was based on the official languages of the major nationalities seeking asylum in 2018, which were Arabic: Syria and Iraq, Farsi: Afghanistan and Iran, and Tigrinya: Eritrea. Informed consent from participants was obtained, and discussions focused on potentially traumatising and protective experiences before, during and after flight. Data collection was complete when data saturation occurred. Interviews were recorded, transcribed, coded and analysed using thematic analysis. We used the socio-ecological model to organise emerging themes that may arise at multiple levels and across all stages of migration. These experiences revolved around eight major themes including six themes reflecting on potentially traumatizing experiences: disruption, rejection, isolation, violence, impediments and affliction; and two themes that reflect on possible protective experiences: security/stability and connections. This study highlights important aspects to consider when examining refugee children's experiences, such as addressing family dispersion, displacement, tough immigration and national policies as ACEs. It is increasingly important to identify these diverse experiences as the refugee population continues to grow and the increased prevalence of poor health outcomes in refugee children has been widely documented. Identifying ACEs specifically relevant for refugee children could contribute to understanding potential pathways and could further serve as a starting point for tailored interventions.

Women leading local humanitarian response during the Covid-19 pandemic

This study explores the hypothesis that not only are women's rights organisations (WROs) working in crisis settings already active in providing humanitarian assistance, but also continued failure to support them in this capacity risks further marginalising and harming their constituencies, entrenching inequalities and undermining efforts towards gender justice. They have demonstrated their deep knowledge and understanding of crisis contexts and the communities they serve, as well as their capability and adaptability. However, they are an underserved and little-recognised set of humanitarian actors. This research examines WROs' experiences of the pandemic and related containment measures in South Sudan and Kenya, but it will hold relevance for international agencies engaged in gender-responsive and local humanitarian action, with recommendations for doing this work more ethically, supportively and appropriately. It will also hold true for a range of other local or place-based civil society organisations (CSOs) serving marginalised communities.

Recommendations

- **All stakeholders operating in humanitarian contexts must centre women leaders**, WROs and other local and place-based CSOs serving marginalised groups in their crisis response strategies, planning, decision-making, implementation and evaluations.
- **Donors should prioritise direct funding for gender-specific humanitarian work** to place-based CSOs, especially WROs. This will enable WROs to continue providing critical services, including for sexual and gender-based violence, without being constrained by limited and contingent funding. Funding should be direct, flexible, core, free from unrealistic due diligence processes, and guided by WROs' own self-defined priorities. There should be a shift away from funding modalities that position international actors as intermediaries between donors and WROs.
- **The humanitarian system needs to resist masking distrust as accountability. Concepts** such as capacity and due diligence should be interrogated for bias and embedded colonialist assumptions. This process should be explicit and result in clear statements on how these concepts will be operationalised going forward. Requirements for funding bids, project proposals and reporting should be adapted to reduce undue administrative burdens on place-based WROs.
- **International actors should work in complementarity rather than in competition with place-based WROs.** For international actors, this means stepping back from activities in which WROs are engaged, including income-generating activities. This will provide WROs with opportunities to diversify their funding base, as they seek economic empowerment outside the humanitarian system. For donors, this means seeking out and directing funds to WROs already working in a particular setting.
- **International non-governmental organisations and others should form cooperative partnerships based on equality** rather than hierarchical, patronising or otherwise unequal power relations.
- **Donors and international actors must integrate an understanding of intersectional exclusions and power dynamics**, taking deliberate action to guarantee that place-based organisations representing marginalised groups including WROs are not excluded. This includes organisations founded by, led by and focused on the needs of Indigenous women; impoverished women; girls and older women; women with disabilities; women of diverse sexual orientations and gender identities; and women from marginalised religious groups, ethnicities, language groups, castes or classes.

Establishing a blockchain-enabled Indigenous data sovereignty framework for genomic data

Abstract

Technological advances have enabled the rapid generation of health and genomic data, though rarely do these technologies account for the values and priorities of marginalized communities. In this commentary, we conceptualize a blockchain genomics data framework built out of the concept of Indigenous Data Sovereignty.

[Excerpts]

... Genomic data from Indigenous peoples in particular have been the target of researchers interested in advancing our understanding of various human diseases and genetic disorders and conditions, often used without free, prior, and informed consent ([Tsosie et al., 2021](#)). Indigenous populations, historically underrepresented in research, have a relatively low degree of European admixture and offer unique insights into genetic variants of interest. In 2021, the NIH All of Us Research Program (a research program focused on building a diverse health history database involving more than one million people) published guidelines for responsible tribal engagement, ensuring that health information specific to Indigenous Americans is protected at all stages of the research process ([National Institutes of Health, 2021](#)). This announcement was met with skepticism given concerns about tribal involvement in genetic research and no explicit focus on returning material benefit to tribes ([Fox, 2020](#)).

We recognize that individual participation in research can have sociopolitical implications for sovereign Indigenous nations. However, there are several challenges to encourage Indigenous nations' participation in genetic research and operationalize Indigenous Data Sovereignty (IDS) (see [Box 1](#) for definition).

:: First, researchers and funding structures may not recognize the authority of Indigenous nations to convene their own Institutional Review Board (IRB) or agree to provide Indigenous nations full data access and ownership ([Harding et al., 2012](#); [Around Him et al., 2019](#)).

:: Second, existing data systems often misclassify Indigenous peoples as members of other racial and ethnic groups, leading to inaccurate data and failure to generate the evidence needed for advocacy and policy making ([Yellow Horse and Huyser, 2021](#)).

:: Finally, Indigenous nations must often navigate complex jurisdictional environments in trying to exert control over their health data ([Walker et al., 2018](#))...

...The overall goal of the IDS blockchain framework is to enable distributed community-mediated management of Indigenous genomic data, digital sequencing information, and associated metadata or state of data that can be useful for non-Indigenous researchers, biotechnology life science companies, and innovators in a privacy-preserving manner (see [Figure 1](#)). In order to do this, technical features of data management will focus on tribal- and community-level permissions, secure multi-factor consent and authorization, and utilizing an off-chain blockchain data management design in order to ensure that underlying genomic data is not shared directly on the blockchain ([Miyachi and Mackey, 2021](#)). This interplay between on-chain and off-chain data storage, processing, and management will be key features of the technical framework proposed. Specifically, hybrid off-chain blockchain systems can enable better scalability, reduce data storage requirements (important due to the large size of genomic data), allow for data querying, and enhance data privacy options ([Miyachi and Mackey, 2021](#))...

Future considerations

While blockchain has the potential to lead to the “democratization” of data through distributed governance, there is a general lack of support for incorporating the values and priorities of marginalized communities into the development and management of these technologies. In this commentary, we identified key strategies needed to align blockchain technology to IDS principles, with a focus on conceptualizing technology that augments organizational capacity for privacy and data autonomy and does not reinvent existing governance and community partnership structures. This technology framework has the potential to establish an innovative distributed governance structure that could functionally enable the management, sharing, and use of Indigenous genomic data consistent with the values and priorities of the sovereign governments from which they originate.

One caveat: we acknowledge that this is an early version of a framework co-ideated with NBDC board member co-authors. To improve our process we plan to prioritize an assortment of community consensus-building tools to seek broader community input, engagement, co-creation, and consent from involved Indigenous leaders and their constituencies through community-based participatory research approaches, particularly around establishing shared understanding of concepts related to privacy and security ([Claw et al., 2018](#)). Further, evaluation of what blockchain platforms might represent the optimal environment to build the IDS framework on will be important considerations. For example, Hyperledger Fabric’s permissioned blockchain environment may offer greater scalability, performance, and security of data while also retaining the ability for rich querying. Ethereum, a popular decentralized blockchain software platform, offers a robust smart contract execution environment and the ability to stand up transparent community-led decentralized autonomous organizations (DAOs) governed by smart contracts...

Overview


This is the second situation report for the multi-country outbreak of monkeypox, which provides details on the latest epidemiology, updates from the Second meeting of the International Health Regulations (2005) (IHR) Emergency Committee, new guidance documents and updates on WHO advice.

Highlights

- The International Health Regulations Emergency Committee on the multi-country outbreak of monkeypox held its second meeting on 21 July 2022. Having considered the views of Committee Members and Advisors as well as other factors in line with the International Health Regulations (2005), the WHO Director-General on 23 July 2022 declared this outbreak a public health emergency of international concern and issued Temporary Recommendations in relation to the outbreak. He stated that “we have an outbreak that has spread around the world rapidly, through new modes of transmission, about which we understand too little, and which meets the criteria in the International Health Regulations...(T)his is an outbreak that can be stopped with the right strategies in the right groups.” He issued temporary recommendations for countries to stop transmission and bring the outbreak under control.
- **All six WHO Regions have now reported cases of monkeypox. Since the situation report published on 6 July, the South-East Asia Region reported confirmed cases.**

- In the African Region, the latest data on monkeypox indicate a significant increase in cases since April 2022, compared to the same period in 2021, which could, in part, be attributed to enhanced monkeypox surveillance and laboratory testing capacity in the countries. The highest number of suspected cases of monkeypox in the region had been reported in 2020.
- WHO has launched a global epidemiological report titled "Multi-Country Monkeypox Outbreak - Global Trends" that is updated at least twice weekly, and the geographic distribution of cases can be viewed using the WHO Health Emergency Dashboard...


Overview

Globally, the number of weekly cases reported during the week of 18 to 24 July 2022 was similar to the number reported last week, with over 6.6 million new cases. Likewise, the number of new weekly deaths was similar to the number reported during the previous week, with over 12 600 fatalities. As of 24 July 2022, over 567 million confirmed cases and over 6.3 million deaths have been reported globally.

This week our selection focuses on **conflict, famine, and migration**. They highlight the importance of examining protection after conflict has officially ended, and the **authority of customary law in holding armed actors to account**. The role of digital technologies in conflict and famine, and humanitarian response, and how humanitarian law could apply, also features. The **conflict in Ethiopia** in particular is covered, not only in Tigray but also the **neglected war in Oromia** – resulting in famine and forced migration. The selected blogs expose the dangers of focussing on **smugglers** as it hides the role of the Western policies in causing harm to people on the move. They also highlight the importance of **listening to refugee voices themselves**. The same applies to **research methods**: issues of informed consent, remuneration, and anonymity need to be reconsidered giving research participants a greater role in balancing risk and recognition.

Research methods based in these artistic forms have grown in prominence as the enterprise of health care has been led by kindred disciplines of bioethics and humanities to interrogate overmedicalization, to resist hyperfocus on measurability when the cost is neglect of narratives and experiences, and to recognize tendencies that too often privilege outcomes over processes. What we've learned is that medicine has much to learn from and contribute to the arts, and that the arts have much to learn from and contribute to medicine.

From the Editor

Arts-Based Research and Health Care

Mark Gilbert, PhD

Artistic or aesthetic ways of knowing have been embraced in many different cultures as forms of healing.^{1, 2} In health care and health professions education, there is increasing interest in the role of arts-based research or integrating the arts into a variety of clinical and community settings for therapeutic, educational, and expressive purposes.^{3, 4...}

This special issue of the *AMA Journal of Ethics* presents myriad ways that artistic expression as a primary mode of inquiry can be used to nurture an inspiring medical education wherein creativity is embraced and can flourish.¹¹ The clinicians, educators, artists, researchers, and students who contributed to this issue make clear how much health professionals and students can learn from engaging with artistic ways of knowing. Moreover, they testify to how the arts can be enriched and informed by health care. My experience of working in clinical contexts has taught me more about communication and silence. We hope this special issue creates opportunities for readers to witness the relationships and interactions fundamental to medicine and to grasp the profound challenges and abundant rewards that await all who engage in arts-based research in clinical, public health, and community contexts.

[Monkeypox: a global wake-up call](#)

WHO's declaration on July 23 that the current monkeypox outbreak constitutes a Public Health Emergency of International Concern (PHEIC) was unprecedented. It is the seventh such declaration, but the first made against the advice of a majority of the emergency committee (nine were against, six were for). Dr Tedros' decision is a brave one. It needs to serve as a global wake-up call. The question is whether it will prompt the escalated efforts required to control the outbreak.

Dr Tedros gave three broad reasons for his decision. "We have an outbreak that has spread around the world rapidly, through new modes of transmission about which we understand too little, and which meets the criteria in the International Health Regulations." The details make for a compelling case. So far this year, up to July 22, 16 016 cases have been reported from 75 countries. Where monkeypox is endemic, such as in DR Congo, large new outbreaks have been reported in diverse populations. Outside of west and central Africa, the outbreak is concentrated, for now, in men-who-have-sex-with-men (MSM). Why the disease's epidemiology has changed is still unclear, as are many other aspects of the outbreak. Recent case series from non-endemic countries have shown differences in clinical features compared with previous reports. Lethargy and fever seem to be less common, and several patients have no prodromal symptoms. Skin lesions are found predominantly in genital or perianal areas. Transmission is known to occur through skin-to-skin contact, but monkeypox DNA has been found in patients' seminal fluid—whether it represents replication-competent virus remains unknown. The rapid worldwide spread of a disease, for reasons we are unsure of, was clearly an over-riding concern for Dr Tedros. An urgent energised research effort is now needed to understand these and other issues related to the outbreak.

Countries must strengthen public health preparedness and response. Case definitions should be updated and harmonised as new data emerge, with heightened surveillance, case detection, and contact tracing. Patients need to be supported in isolation and treatment, and targeted immunisation might be needed for people at high risk of exposure. Recent experience with COVID-19 might help countries institute these measures but many health systems are at breaking point already. There is a risk too that the public is fatigued by talk of pandemics and their control. Misinformation about monkeypox has already begun to circulate. The public need to be engaged and targeted risk-communication strategies developed. Monkeypox is not COVID-19. The R0 is around 1, and transmission mechanisms are entirely different. The clade of monkeypox that seems to be responsible for the outbreak largely causes mild self-limiting illness, although patients have been admitted to hospital, mainly for pain. Ensuring wide understanding of these points is key for managing public anxiety.

Engagement among many MSM has been high since the outbreak started, and this population is—as ever—keen to take care of its health (and do their part to protect others). Countries that criminalise homosexuality and marginalise LGBTI+ communities risk both patients' wellbeing and chances of controlling transmission. Stigma and discrimination need to be fought. It would be wrong to categorise monkeypox as a disease of MSM.

The expedited pathways for research, development, regulatory approval, and manufacturing of medical countermeasures developed for COVID-19 should be repurposed for monkeypox. A lack of diagnostic tests is hampering case identification in some countries. Tecovirimat, originally produced to treat smallpox, has been licenced by European regulators for monkeypox, but not yet by the US FDA. Other promising treatments, such as cidofovir and brincidofovir, require clinical study. A monkeypox vaccine (sold as Imvanex in Europe and Jynneos in the USA) has been approved, but supplies of both treatments and vaccines are extremely limited. WHO will have to take a much more muscular approach to ensure global access and avoid the inequities of the COVID-19 response.

Whether or not you agree with WHO's decision, there has undoubtedly been a missed opportunity. Monkeypox is not new. It has been causing illness and death in large numbers for decades. Specialists have long called for affordable countermeasures, strengthened surveillance, and more study. But like Ebola and Zika, monkeypox only commands global attention when it hits high-income countries with predominantly White populations. As a result, the window of opportunity to prevent monkeypox becoming established in communities worldwide is closing. Now is a key moment. It warrants the strongest medical, scientific, and political global effort.

Data rescue: saving environmental data from extinction

Abstract

Historical and long-term environmental datasets are imperative to understanding how natural systems respond to our changing world. Although immensely valuable, these data are at risk of being lost unless actively curated and archived in data repositories. The practice of data rescue, which we define as identifying, preserving, and sharing valuable data and associated metadata at risk of loss, is an important means of ensuring the long-term viability and accessibility of such datasets. Improvements in policies and best practices around data management will hopefully limit future need for data rescue; these changes, however, do not apply retroactively. While rescuing data is not new, the term lacks formal definition, is often conflated with other terms (i.e. data reuse), and lacks general recommendations. Here, we outline seven key guidelines for effective rescue of historically collected and unmanaged datasets. We discuss prioritization of datasets to rescue, forming effective data rescue teams, preparing the data and associated metadata, and archiving and sharing the rescued materials. In an era of rapid environmental change, the best policy solutions will require evidence from both contemporary and historical sources. It is, therefore, imperative that we identify and preserve valuable, at-risk environmental data before they are lost to science.

Abstract

Refugee children experience potentially traumatic events that are distinct from the general population, yet current Adverse Childhood Experience (ACE) research addressing these specific adversities is scarce. This study uses qualitative interviews to identify potentially traumatising and protective experiences subjectively perceived as having an effect on the wellbeing of refugee children. Semi-structured interviews with 47 refugee parents and 11 children (aged 8-17) were conducted between November 2018 and January 2020 in the Rhine-Neckar region in Germany. Sampling was based on the official languages of the major nationalities seeking asylum in 2018, which were Arabic: Syria and Iraq, Farsi: Afghanistan and Iran, and Tigrinya: Eritrea. Informed consent from participants was obtained, and discussions focused on potentially traumatising and protective experiences before, during and after flight. Data collection was complete when data saturation occurred. Interviews were recorded, transcribed, coded and analysed using thematic analysis. We used the socio-ecological model to organise emerging themes that may arise at multiple levels and across all stages of migration. These experiences revolved around eight major themes including six themes reflecting on potentially traumatizing experiences: disruption, rejection, isolation, violence, impediments and affliction; and two themes that reflect on possible protective experiences: security/stability and connections. This study highlights important aspects to consider when examining refugee children's experiences, such as addressing family dispersion, displacement, tough immigration and national policies as ACEs. It is increasingly important to identify these diverse experiences as the refugee population continues to grow and the increased prevalence of poor health outcomes in refugee children has been widely documented. Identifying ACEs specifically relevant for refugee children could contribute to understanding potential pathways and could further serve as a starting point for tailored interventions.

Abstract

Digital data play an increasingly important role in advancing medical research and care. Abstract

Background: The coronavirus disease 2019 (COVID-19) has resulted in an unprecedented research response, demonstrating exceptional examples of rapid research and collaboration. Drawing data continually from their members and further global funding bodies, as of 15th October 2021 the database contains 13,484 projects, funded by 285 funders, taking place across 156 countries representing an investment of at least \$5.1 billion. To our knowledge it is one of the most comprehensive databases. The database is aligned to the World Health Organisation and GloPID-R Global Research Roadmap: 2019 Novel Coronavirus. It is being used by the WHO, governments and multi-lateral policy makers, research funders and researchers.

This living mapping review aims to supplement the database by providing an open accessible and frequently updated resource summarising the characteristics of the COVID-19 funded research portfolio. Both descriptive and thematic analysis will be presented and updated frequently to aid

interpretation of the global COVID-19 funded research portfolio.

Results: In this version six analysis we provide an updated detailed descriptive analysis of the database (on data from three months after version five) and focus our thematic analysis on research gaps, research areas in need of coordination, study populations and research locations (with a focus on resource-limited countries).

Conclusions: As the global funding response to COVID-19 plateaus, this living mapping review helps both funders and researchers to prioritise resources to areas where there is continued unmet research need.

Project funder.

The 13,484 projects included in the latest version of the tracker comprises of data compiled from 285 research funders based in 53 different countries representing an investment of at least \$5.1 billion (funding amounts only available for 58.2% of projects) ([Figure 2](#)). This represents an increase of more than 10% in the number of funders (previously 255 funders based in 51 countries) since the previous version of the analysis
