**[As impacts accelerate, adapting to climate change must become a global priority – UNEP report](#)**

- More than eight out of ten parties to UNFCCC have adaptation planning instruments in place
- Estimated adaptation costs are five to ten times greater than international adaptation finance flows to developing countries
- Unprecedented political will and long-term investments in adaptation are urgently needed

Nairobi, 3 November 2022 – As climate impacts intensify across the globe, nations must dramatically increase funding and implementation of actions designed to help vulnerable nations and communities adapt to the climate storm, according to a new United Nations Environment Programme (UNEP) report. Released ahead of COP27 – the latest round of climate talks taking place in Sharm El-Sheikh, Egypt – [\*\*The Adaptation Gap Report 2022: Too Little, Too Slow – Climate adaptation failure puts world at risk\*\*](#), finds that global efforts in adaptation planning, financing and implementation are not keeping pace with the growing risks.

**"Adaptation needs in the developing world are set to skyrocket to as much as \$340 billion a year by 2030. Yet adaptation support today stands at less than one-tenth of that amount. The most vulnerable people and communities are paying the price. This is unacceptable,"** UN Secretary-General António Guterres said in a statement on the release of the Adaptation Gap Report. "Adaptation must be treated with a seriousness that reflects the equal worth of all members of the human family. It's time for a global climate adaptation overhaul that puts aside excuses and picks up the toolbox to fix the problems," he added...

### [\*\*Statement: A Message from the Presidents of the U.S. National Academies as COP27 Begins in Egypt\*\*](#)

November 4, 2022

The COP27 climate summit offers an opportunity to make greater progress on transitioning to a low-emissions world while protecting nations and communities that are most affected by the impacts of climate change, as well as maintaining food and water security around the world — both of which are under stress. The summit also can advance innovations in how nations finance climate-resilient development and invest in future energy infrastructure.

We are seeing encouraging signs of progress in reducing greenhouse gas emissions as renewable energy sources become more widely available and affordable, and here in the U.S., the recent passage of historic legislation to incentivize the shift to clean energy should help boost domestic efforts. Nevertheless, our country, along with much of the world, is still lagging behind in reaching critical emission-reduction targets. Without urgent and sustained action, extreme events such as this year's record-breaking heat waves in the U.S., devastating droughts in China and Europe, and deadly floods in Pakistan could become the "new normal," with society's most vulnerable at particular risk.

**We call upon world leaders in government, business, and civil society to continue to work together to forge effective and equitable solutions to the climate crisis. At the U.S. National Academies, we are committed to enlisting science, engineering, and medicine to inform these efforts so that together, we can create a more secure, more sustainable, and more prosperous future for all.**

### [UN Human Rights Chief Türk issues open letter to Twitter's Elon Musk](#)

GENEVA (5 November 2022) – UN High Commissioner for Human Rights Volker Türk on Saturday issued an open letter to Elon Musk, Chief Executive Officer at Twitter, urging him to “ensure human rights are central to the management of Twitter” under Musk’s leadership:

### **Open Letter from Volker Türk, UN High Commissioner for Human Rights, to Mr. Elon Musk, Chief Executive Officer at Twitter**

5 November 2022

Dear Mr. Musk:

Twitter is part of a global revolution that has transformed how we communicate. I value Twitter for what I have learned and been able to share with people all around the world, easily and effectively. But I write with concern and apprehension about our digital public square and Twitter’s role in it.

As the new owner of Twitter, you have enormous responsibilities given the platform’s influential role as a digital space where people discuss their ideas, their worries and their lives. Twitter should be a place that is safe, and where people’s rights are respected. Like all companies, Twitter needs to understand the harms associated with its platform and take steps to address them. Respect for our shared human rights should set the guardrails for the platform’s use and evolution.”

**“In short, I urge you to ensure human rights are central to the management of Twitter under your leadership. Reports that Twitter’s entire human rights team and all but two of its ethical AI team have been fired this week are not, from my perspective, an encouraging start.**

**I wish to share with you and your new team some fundamental principles from a human rights perspective that I would urge be front and centre as you go forward:**

#### **[1] Protect free speech across the globe.**

In many contexts, Twitter, alongside other social media companies, is being pressed by governments globally to take steps to undermine free speech, whether by taking down content that is entirely legitimate under international standards, or using upload filters. We urge Twitter to respond to such demands by standing up for the rights to privacy and free expression to the full extent possible, under relevant laws, and by transparently, promptly and regularly reporting on Government requests – or pressures – that infringe those rights.

#### **[2] Free speech is not a free pass.**

Conversely, viral spread of harmful disinformation, such as we have seen during the Covid-19 pandemic in relation to vaccines, results in real world harms. Twitter has a responsibility to avoid amplifying content that results in harm to other people’s rights.

#### **[3] There is no place for hatred that incites discrimination, hostility or violence on Twitter.**

Human rights law is clear – freedom of expression stops at hatred that incites discrimination, hostility or violence. We know from our own investigation that hate speech has spread like wildfire on social media platforms in countries with starkly different cultural, political and religious contexts – with horrific, life-threatening consequences for thousands of people. Twitter’s content moderation policies should continue to bar such hatred on the platform, and every effort needs to be made to remove such content promptly.

#### **[4] Transparency is key.**

Research is essential to understand better the impact of social media on our societies. We urge you to maintain access to Twitter’s data through its open APIs [application programming interfaces].

**[5] Protect privacy.**

Free speech depends on effective protection of privacy. It is vital that Twitter refrain from invasive user tracking and amassing related data and that it resist, to the fullest extent possible under applicable laws, unjustified requests from governments for user data. I also urge Twitter to transparently inform users and the public about the steps it takes.

**[6] Languages and contextual expertise are not optional.**

Twitter’s responsibilities to maintain a rights-respecting and safe platform apply not just to English-language content, or in the United States of America, but globally. Twitter should have sufficient content moderation capacity in all the languages and contexts in which it does business.

Twitter’s responsibilities to respect human rights, and to address human rights impacts relating to its operations, are set out in more detail in the [UN Guiding Principles on Business and Human Rights](#), and through my Office’s [B-Tech project](#) that works to apply those principles in practice within the technology sector. Twitter has been an active participant in the Community of Practice within that project, which we hope will continue.

**Twitter has much to offer to our common agenda for a better world, but we need to be clear-eyed as to what is required to make that a reality. In a world as complex as ours has become, our shared human rights offer a unifying way forward.** We look forward to working with you.

**[New human rights philanthropy report shows encouraging trends, also reveals increased disparities in 2019](#)**

*2022 report from Candid and Human Rights Funders Network shows that there is room for growth*

New York, NY—November 1, 2022. Candid and Human Rights Funders Network (HRFN) today released [Advancing Human Rights: Annual Review of Global Foundation Grantmaking 2019 Key Findings](#). The annual report reveals insights from the most up-to-date, comprehensive data available for global human rights philanthropy.

**This year’s analysis found that in 2019, 761 funders made over 26,000 human rights grants totaling \$4.1 billion.** The report notes: “Human rights funding is a fraction of what’s needed – and what’s possible.”...

**Key findings include:**

- **Human rights funding continues to increase, but with regional funding disparities.** Over the past decade, we have seen sustained yet diminishing growth in human rights grant dollars. The report documents a 10% increase from 2018 and a 242% increase over the past ten years. At the same time, there are considerable regional disparities, with grants in North America growing at a greater rate than other regions. In Sub-Saharan Africa, funding declined for a second year in a row, and was stagnant the year before that.

- **Funding increased for six of nine populations.** Among funders who shared grants data in 2018 and 2019, support for racial and ethnic groups grew the most. Nearly three out of four funders that fund with a racial or ethnic lens increased their spending. Likewise, persons with disabilities, which saw a decrease in 2018, increased in 2019 by 38%. Funding decreased for three groups: Indigenous peoples, human rights defenders, and children and youth, after growth in each of these areas the previous year.
- **The majority of human rights grants focus on one population. Seventy-two** percent of the human rights grants awarded in 2019 either didn't mention any populations or named just one. Only 28% were intended to benefit more than one population and just 7% reference three or more – for example women of color who identify as LBTQI. This suggests that the bulk of human rights funding is failing to consider intersectional identities or support critical cross-movement work.
- **Funding from foundations in the Global South and East is increasing.** While the proportion of funding that is controlled by Global South and East funders continues to hover at around 1% of total human rights grant dollars, a notable three fourths of these foundations increased their grantmaking since the previous year. Global South and East funders represent a vital source of resourcing for locally-led initiatives, with 93% of grants by these funders staying within these regions.
- **Trust remains an issue.** We continue to see more restricted, less direct funding for grants to the Global South and East. Groups that are awarded human rights grants in North America are five times more likely to receive direct, flexible support than those in Sub-Saharan Africa and seven times more likely than groups in the Caribbean.

Human Rights Funders Network Executive Director Kellea Miller said, “We’re encouraged that human rights philanthropy continues to grow. But we can’t lose sight of **the fact that human right grants only make up 2–8% of total foundation funding each year**. We hope this report helps funders see the potential to bring more resources to the field. We also hope it helps foundations address the global imbalance in resourcing, increase direct, flexible funding, and adopt an intersectional approach to giving.”

**[Association between democratic governance and excess mortality during the COVID-19 pandemic: an observational study](#)** (29 June, 2022) *Free*

*Abstract*

Background

Excess mortality has been used to assess the overall health impact of COVID-19 across countries. Democracies aim to build trust in government and enable checks and balances on decision making, which may be useful in a pandemic. But during the pandemic, they have been criticised as being hesitant to enforce restrictive public health measures.

Methods

Through linking open-access datasets we constructed univariable and multivariable linear regression models investigating the association between country V-Dem Liberal Democracy Indices (LDI), representing strength of democratic governance and excess mortality rates, from January 2020 to

September 2021. We adjusted for several important confounders and conducted a range of sensitivity analyses to assess the robustness of our findings.

#### Results

Across 78 countries, 4.19 million excess deaths were recorded. On multivariable regression, a one-point increase in V-Dem LDI was associated with a decrease in excess mortality of 2.18 per 100 000 ( $p=0.004$ ), after accounting for age, gender, wealth and universal health coverage. This association was only partially attenuated by COVID-19 vaccination rates and remained robust in all sensitivity analyses.

#### Conclusions

Democratic governance may have played an important role in mitigating the overall health impact of COVID-19 across countries. This study strengthens the case to broaden the scope of traditional pandemic risk assessment and discussions on preparedness.

#### [Shared Cultural Ancestry Predicts the Global Diffusion of Democracy](#)

*Countries with shared linguistic and religious ancestry have similar democracy outcomes.*

*Abstract*

Understanding global variation in democratic outcomes is critical to efforts to promote and sustain democracy today. Here, we use data on the democratic status of 221 modern and historical nations stretching back up to 200 years to show that, particularly over the last 50 years, nations with shared linguistic and, more recently, religious ancestry have more similar democratic outcomes. We also find evidence that for most of the last 50 years the democratic trajectory of a nation can be predicted by the democratic status of its linguistic and, less clearly, religious relatives, years and even decades earlier. These results are broadly consistent across three democracy indicators (Polity 5, Vanhanen's Index of Democracy, and Freedom in the World) and are not explained by geographical proximity or current shared language or religion. Our findings suggest that deep cultural ancestry remains an important force shaping the fortunes of modern nations, at least in part because democratic norms, institutions, and the factors that support them are more likely to diffuse between close cultural relatives.



## [Weekly epidemiological update on COVID-19 - 2 November 2022](#)

### *Overview*

Globally, the number of new weekly cases decreased by 17% during the week of 24 to 30 October 2022, as compared to the previous week, with over 2.3 million new cases reported. The true number of incident cases is likely to be underestimated due to a decline in testing globally. The number of new weekly deaths decreased by 5%, as compared to the previous week, with about 9300 fatalities reported. As of 30 October 2022, 627 million confirmed cases and 6.5 million deaths have been reported globally.

### *Overview*

This is the ninth situation report for the multi-country outbreak of monkeypox, which provides details on the latest epidemiology, updates on clinical care, therapeutics, and key recommendations of third IHR EC meetings. The report also provides an update on the situation in the Region of the Americas.

### Highlights

:: During the week of 17 to 30 October 2022, the number of monkeypox cases reported in the Regions of Europe and the Americas continue to decline, driving the overall downward trend observed since August 2022. The Region of the Americas continues to account for the highest cumulative proportion of monkeypox cases reported globally and the highest proportion of weekly new cases.

:: For strategic planning and global support, WHO is appealing for US\$ 33.82 million (between July 2022 and June 2023) to take immediate action to stop the monkeypox outbreak in collaboration with the Member States, partners, and other stakeholders. The global appeal covers all six WHO regions, with the greatest needs in the African Region, South-East Asia, and the Eastern Mediterranean in the areas of vaccination (34%), surveillance and contact tracing (17%), diagnostics and testing (13%), and risk communication and community engagement (13%)...

### [Third meeting of the International Health Regulations \(2005\) \(IHR\) Emergency Committee regarding the multi-country outbreak of monkeypox](#)

1 November 2022 *Statement*

The third meeting of the International Health Regulations (2005) (IHR) Emergency Committee regarding the multi-country outbreak of monkeypox, was held on Thursday, 20 October 2022. The Emergency Committee acknowledged that some progress has been made in the global response to the multi-country outbreak of monkeypox since the last meeting, including the emerging information on the effectiveness of behavioural interventions and vaccines.

**The Committee held the consensus view that the event continues to meet the IHR criteria for a Public Health Emergency of International Concern (PHEIC)** and highlights the primary reasons for ongoing concern. These include ongoing transmission in some regions, continuing preparedness and response inequity within and between WHO Member States, an emerging potential for greater health impact in vulnerable populations, continuing risk of stigma and discrimination, weak health systems in some developing countries leading to under-reporting, ongoing lack of equitable access to diagnostics, antiviral and vaccines, and research gaps needing to be addressed.

The **WHO Director-General expresses his gratitude to the Chair, Members, and Advisors for their advice and concurs with this advice that the event continues to constitute a PHEIC** for the reasons detailed in the proceedings of the meeting below. ## Statement of the Thirty-third Polio IHR Emergency Committee

1 November 2022

### Statement

The thirty-third meeting of the Emergency Committee under the International Health Regulations (2005) (IHR) on the international spread of poliovirus was convened by the WHO Director-General on 12 October 2022 with committee members and advisers attending via video conference, supported by the WHO Secretariat. The Emergency Committee reviewed the data on wild poliovirus (WPV1) and circulating vaccine derived polioviruses (cVDPV) in the context of global eradication of WPV and cessation of outbreaks of cVDPV2 by end of 2023. Technical updates were received about the situation in the following countries and territories: Afghanistan, Algeria, Malawi, Mozambique, Pakistan, the United Kingdom of Great Britain and Northern Ireland, the United States of America and Yemen....

### *... Conclusion*

**Although encouraged by the reported progress, the Committee unanimously agreed that the risk of international spread of poliovirus remains a Public Health Emergency of International Concern (PHEIC) and recommended the extension of Temporary Recommendations for a further three months.** The Committee recognizes the concerns regarding the lengthy duration of the polio PHEIC and the importance of exploring alternative IHR measures in the future but concluded that there are still significant risks as exemplified by the importation and continued transmission of virus in Malawi and Mozambique. The Committee considered the following factors in reaching this conclusion:

**... Based on the current situation regarding WPV1 and cVDPVs, and the reports provided by affected countries, the Director-General accepted the Committee's assessment and on 21 October 2022 determined that the poliovirus situation continues to constitute a PHEIC with respect to WPV1 and cVDPV...**

*Abstract*

Host genetics is a key determinant of COVID-19 outcomes. Previously, the COVID-19 Host Genetics Initiative genome-wide association study used common variants to identify multiple loci associated with COVID-19 outcomes. However, variants with the largest impact on COVID-19 outcomes are expected to be rare in the population. Hence, studying rare variants may provide additional insights into disease susceptibility and pathogenesis, thereby informing therapeutics development. Here, we combined whole-exome and whole-genome sequencing from 21 cohorts across 12 countries and performed rare variant exome-wide burden analyses for COVID-19 outcomes. In an analysis of 5,085 severe disease cases and 571,737 controls, we observed that carrying a rare deleterious variant in the SARS-CoV-2 sensor toll-like receptor TLR7 (on chromosome X) was associated with a 5.3-fold increase in severe disease (95% CI: 2.75–10.05,  $p = 5.41 \times 10^{-7}$ ). This association was consistent across sexes. These results further support TLR7 as a genetic determinant of severe disease and suggest that larger studies on rare variants influencing COVID-19 outcomes could provide additional insights.

#### *Author summary*

COVID-19 clinical outcomes vary immensely, but a patient's genetic make-up is an important determinant of how they will fare against the virus. While many genetic variants commonly found in the populations were previously found to be contributing to more severe disease by the COVID-19 Host Genetics Initiative, it isn't clear if more rare variants found in less individuals could also play a role. This is important because genetic variants with the largest impact on COVID-19 severity are expected to be rarely found in the population, and these rare variants require different technologies to be studied (usually whole-exome or whole-genome sequencing). Here, we combined sequencing results from 21 cohorts across 12 countries to perform a rare variant association study. In an analysis comprising 5,085 participants with severe COVID-19 and 571,737 controls, we found that the gene for toll-like receptor 7 (TLR7) on chromosome X was an important determinant of severe COVID-19. Importantly, despite being found on a sex chromosome, this observation was consistent across both sexes.

*Abstract*

This study explores how researchers' analytical choices affect the reliability of scientific findings. Most discussions of reliability problems in science focus on systematic biases. We broaden the lens to emphasize the idiosyncrasy of conscious and unconscious decisions that researchers make during data analysis. We coordinated 161 researchers in 73 research teams and observed their research decisions as they used the same data to independently test the same prominent social science hypothesis: that greater immigration reduces support for social policies among the public. In this typical case of social science research, research teams reported both widely diverging numerical findings and substantive conclusions despite identical start conditions. Researchers' expertise, prior beliefs, and expectations barely predict the wide variation in research outcomes. More than 95% of the total variance in numerical results remains unexplained even after qualitative coding of all identifiable decisions in each team's workflow. This reveals a universe of uncertainty that remains hidden when considering a single study in isolation. The idiosyncratic nature of how researchers' results and conclusions varied is a previously underappreciated explanation for why many scientific hypotheses remain contested. These results call for greater epistemic humility and clarity in reporting scientific findings.
