Open letter from the United Nations High Commissioner for Human Rights on the post-2020 Global Biodiversity Framework

02 December 2022

[Excerpt]

3. Safeguard meaningful and informed participation and access to justice

All people have the rights to participation, access to information, and access to justice in environmental matters. These rights must be freely exercised without fear of retaliation or reprisal. Positive human rights and conservation outcomes depend on the empowerment and full and equal participation of all people in decisions that impact them, including women, children, Indigenous Peoples, local communities and persons in vulnerable situations. Protecting environmental human rights defenders contributes to fulfilling the right to a healthy environment.

I urge you to adopt a post-2020 Global Biodiversity Framework that upholds the rights to participation, access to information, and access to justice., and that seeks to put a stop to the harassment, persecution and even killing of environmental human rights defenders advocating for the protection of the environment for current and future generations...

Ten key messages for the Convention on Biological Diversity

International Science Council

02.12.2022

Ahead of the United Nations Biodiversity Conference (COP15), the scientific community represented by the ISC calls for The Global Biodiversity Framework (GBF) to encompass ambitious and integrated action, grounded in science, in order to halt alarming biodiversity loss and restore biodiversity as part of human wellbeing.

[1] Biodiversity loss and the decline of ecosystem services continue to worsen at an alarming rate worldwide putting people's lives, livelihoods and wellbeing at great risk. Biodiversity loss and the diminishing capacity of nature to support people compromises our ability to meet the Sustainable Development Goals. The world has failed to meet its global commitment to date in curbing the loss of biodiversity. None of the 20 Aichi targets for biodiversity set in 2010 have been reached and only six have been partially achieved. The Global Biodiversity Framework envisaged to emerge from COP15 will be crucial in guiding national and local action towards 2030.

[2] COP15 is not only a critical time for deciding on collective goals for biodiversity for the next 10 to 30 years, it is also an opportunity to make a critical shift in how we understand and value nature and act upon that knowledge. Science, through inter- and trans-disciplinary research, can provide actionable knowledge into relevant multistakeholder dialogues and ultimately science advice to governments on all dimensions of biodiversity loss and the consequent erosion of ecosystem services and the benefits derived from those. The GBF ought to recognize explicitly the role of science in designing, operationalizing and assessing progress in the realization of the targets under the GBF.

[3] The Global Biodiversity Framework (GBF) must embrace people as part of nature: people should not only be seen as threats and 'takers' but importantly as stewards with a responsibility to conserve and restore biodiversity as part of human well-being.

[4] Biodiversity loss including ecosystem deterioration is not only an environmental issue, it is also a development issue, an equity issue, a health issue, and more. Successful implementation of the GBF will require biodiversity to be mainstreamed across all policy areas, including economic policies.

[5] The GBF needs to put a stronger emphasis on addressing the direct and indirect drivers of biodiversity loss in an explicit and systematic manner. No additional conservation efforts can replace ambitious and concerted efforts to address the drivers of biodiversity loss; if such efforts are not in place, conservation actions will be largely wasted. This also needs to be reflected in the monitoring component of the GBF through which progress on the implementation of the GBF will be reviewed and measured.

[6] Ambitious and integrated actions that maximize co-benefits and minimize trade-offs are needed in the three core interrelated objectives of the Convention on Biological Diversity, namely the conservation of biodiversity, the sustainable use of its components and the equitable sharing of the benefits deriving from biodiversity. Meeting these objectives cannot be met without reducing, and ideally halting, the loss of biodiversity.

[7] Conservation remains essential and needs to be further expanded in four key directions: (i) nurturing diversity from genes to ecosystems, (ii) delivering equitable outcomes with and for local communities, (iii) shifting from fortress conservation to expanding conservation across the full spectrum of managed ecosystems including in cities, and agricultural landscapes, (iv) expanding from conservation of species and spaces to maintaining broader ecosystem functioning and resilience.

[8] The continuing decline in biodiversity, including ecosystem functioning, profoundly affects our capacity to mitigate and adapt to climate change with acute impacts for poor and marginalized groups. In the face of high uncertainty related to accelerated and more intense global environmental change, including climate extremes, effectively functioning ecosystems play a vital role in buffering impacts of extreme events, preventing disasters, and building resilience.

[9] Bridging the gap between goal-setting and actions requires a clear definition of the links and pathways to action, ensuring thus that actions are coherent and commensurate with the desired outcomes. This is a necessary step to align governance arrangements, partnerships, funding, the different roles and responsibilities of all actors, and measures of progress on shared goals. This also implies explicit identification and targeting of activities across all sectors, especially those with negative impacts on biodiversity.

[10] Delivering change will require a mix of bottom up and top-down approaches that promote innovation and solutions that meet the diversity of needs and interests of local communities. A stronger emphasis on territorial governance is needed to deliver the GBF. That emphasis must bring together and align land-use planning, natural resource management, social and economic development of territories, and the planning and implementation of resilient infrastructure to meet biodiversity and wider sustainability goals. Better and more agile coordination with top-down governance is also needed to allow for adequate resources mobilization, institutional support, alignment of governance arrangements, learning and reporting.

Humanitarian Action – Funding

[UN launches record \\$51.5 billion humanitarian appeal for 2023 \[EN/AR\]](#)

(Riyadh, 1 December 2022): Next year will set another record for humanitarian relief requirements with **339 million people in need of assistance in 69 countries, an increase of 65 million people compared to the same time last year**, the United Nations and partner organizations said today.

The estimated cost of the humanitarian response going into 2023 is **US\$51.5 billion, a 25 per cent increase compared to the beginning of 2022**, according to the 2023 Global Humanitarian Overview (GHO)...

The Overview paints a stark picture of what lies ahead:

- :: At least 222 million people in 53 countries will face acute food insecurity by the end of 2022. Forty-five million people in 37 countries risk starvation.
- :: Public health is under pressure by COVID-19, monkeypox, vector-borne diseases and outbreaks of Ebola and Cholera.
- :: Climate change is driving up risks and vulnerability. By the end of the century, extreme heat could claim as many lives as cancer.
- :: Ten countries have appeals exceeding \$1 billion: Afghanistan (\$4.6 billion), Syria (\$4.4 billion), Ukraine (\$3.9 billion), Yemen (\$4.2 billion), Ethiopia (\$3.5 billion) the Democratic Republic of the Congo and Somalia (\$2.3 billion each), South Sudan and Sudan (\$1.7 billion each), and finally Nigeria (\$1.2 billion).

“Two of the major humanitarian challenges to addressing global food insecurity are lack of safe humanitarian access to areas in which aid is most needed, and insufficient levels of funding,” Dr. Abdullah Al Rabeeah, Adviser to the Saudi Royal Court and Supervisor General of King Salman Humanitarian Aid and Relief Centre. “Humanitarian organizations must work closely with governments to ensure the safe transport of aid to those most in need while also providing protection for aid workers. Also, we must encourage all countries able to do so to step up their funding levels urgently to alleviate the catastrophic levels of suffering we are seeing today in so many parts of the world.”...

Donors have provided a generous \$24 billion in funding as of mid-November 2022, but needs are rising faster than the financial support. The funding gap has never been greater, currently at 53 per cent. Humanitarian organizations are therefore forced to make calls who to target with the funds available.

Ukraine – Rebuilding

Statement by President von der Leyen on Russian accountability and the use of Russian frozen assets

Statement – European Commission 30 November 2022

Russia's invasion of Ukraine has brought death, devastation and unspeakable suffering. We all remember the horrors of Bucha.

First, Russia must pay for its horrific crimes, including for its crime of aggression against a sovereign state. This is why, while continuing to support the International Criminal Court, **we are proposing to set up a specialised court, backed by the United Nations, to investigate and prosecute Russia's crime of aggression.**

We are ready to start working with the international community to get the broadest international support possible for this specialised court.

Secondly, Russia must also pay financially for the devastation that it caused. The damage suffered by Ukraine is estimated at 600 billion euros. Russia and its oligarchs have to compensate Ukraine for the damage and cover the costs for rebuilding the country.

And we have the means to make Russia pay. We have blocked 300 billion euros of the Russian Central Bank reserves and we have frozen 19 billion euros of Russian oligarchs' money. **In the short term, we could create, with our partners, a structure to manage these funds and invest them. We would then use the proceeds for Ukraine. And once the sanctions are lifted, these funds should be used so that Russia pays full compensation for the damages caused to Ukraine.**

We will work on an international agreement with our partners to make this possible. And together, we can find legal ways to get to it. Russia's horrific crimes will not go unpunished.

Global Health – Equity

Global report on health equity for persons with disabilities: executive summary

Overview

An estimated 1.3 billion people – or 16% of global population worldwide – experience a significant disability today. Persons with disabilities have the right to the highest attainable standard of health as those without disabilities. However, the WHO Global report on health equity for persons with disabilities demonstrates that while some progress has been made in recent years, the world is still far

from realizing this right for many persons with disabilities who continue to die earlier, have poorer health, and experience more limitations in everyday functioning than others...

Objectives of the report

This Global report on health equity for persons with disabilities identifies and analyses the contributing factors to systemic health inequities for persons with disabilities and outlines key policy and programmatic actions along with recommendations to reduce these health inequities.

The report calls on WHO Member States to take action to advance health equity for persons with disabilities. It also invites civil society, including organizations of persons with disabilities and other health partners, to collaborate and advocate for the implementation of the recommendations included in the report, so that persons with disabilities can achieve the highest attainable standard of health.

The overarching aim of the report is to make health equity for persons with disabilities a global health priority. The specific objectives are to:

- bring health equity for persons with disability to the attention of decision-makers in the health sector;
- document evidence on health inequities and country experiences on approaches to advance health equity from a disability lens; and
- make evidence-based recommendations that stimulate country-level action.

2. Health inequities experienced by persons with disabilities, and their contributing factors

Overview

- Persons with disabilities face many health inequities: they die earlier, have poorer health and functioning, and are more affected by health emergencies than the general population.
- These inequities in health outcomes are unjust and largely cannot be explained in terms of the person's underlying health condition or impairment.
- **Inequities arise from unfair conditions that affect persons with disabilities disproportionately and that are part of:**
 - **Structural factors:** the socioeconomic and political context and the mechanisms that generate social stratification in society.
 - **Social determinants of health:** the conditions in which people are born, grow, live, work and age.
 - **Risk factors:** the factors associated with NCDs, including tobacco use, diet, alcohol consumption and amount of exercise; and environmental factors such as air pollution. The increased exposure to risk factors for persons with disabilities is due significantly to public health interventions often not being inclusive.
 - **Health systems:** the barriers across all building blocks – in service delivery, the health and care workforce, health information systems, and the financing and leadership of health systems.
- **COVID-19 has uncovered structural, social and health system factors that drive health inequities for persons with disabilities.** While these factors are prominent in other health emergencies, the unprecedented number of scientific publications relating to COVID-19 have helped unpack and better understand the contributing factors to health inequities experienced by persons with disabilities.
- **The lessons learned from the COVID-19 pandemic can shape the way forward for achieving health equity for persons with disabilities.** These include, for example, the importance of the provision of accessible health services close to where people live; the engagement and participation of persons with disabilities in the processes and decision-making of the health sector; and the delivery of public health interventions and information in an accessible format.



Weekly epidemiological update on COVID-19 - 30 November 2022

Overview

Globally, the number of new weekly cases remained stable (+2%) during the week of 21 to 27 November 2022, as compared to the previous week, with just under 2.7 million new cases reported. The number of new weekly deaths decreased by 5%, as compared to the previous week, with about 8400 fatalities reported. As of 27 November 2022, 637 million confirmed cases and 6.6 million deaths have been reported globally...

Multi-country outbreak of mpox, External situation report #11 - 1 December 2022

Highlights

:: Following a series of consultations with global experts, WHO will begin using the term “mpox” as the preferred name for the disease of monkeypox. Both names will be used simultaneously for one year while “monkeypox” is phased out. During the week of 21 to 27 November 2022, the number of mpox cases reported globally continued to decline.

:: In the week commencing 21 November, the Eastern Mediterranean Region has reported six new cases after five consecutive weeks without cases. These are retrospective reports of cases diagnosed between 1 October and 25 November 2022.

:: Since the last situation report published on 16 November, 1696 new cases (2.1% increase in total cases) and five new deaths have been reported.

:: Since the beginning of the outbreak, a high prevalence of HIV infection (52%; 14 573/28 006) has been reported among cases with known HIV status.

:: The proportion of cases among females has been gradually increasing since the beginning of the outbreak, reaching 6.7% as of 20 November 2022

Polio

Polio this week as of 30 November 2022 - GPEI

:: In Indonesia, following confirmation last week of VDPV2 isolated from an AFP case (7-year old child) with onset of paralysis on 9 October, from Aceh province, circulating of this strain has been confirmed following isolation of the virus from three healthy community contacts. See ‘Indonesia’ section below,

:: At a WHO Member State Information Session on 16th November, regional and programme representatives set out the actions being taken in 2023 to step up polio transition efforts towards strengthening health systems, bolstering immunization and disease surveillance, and protecting against polio outbreaks. Particular focus is on the development of a global vision for polio transition, supported by tailored regional action plans and a strengthened monitoring and evaluation framework, building on successes and lessons learned so far.

:: nOPV2 rollout: Approximately 525 million doses of nOPV2 have been administered across 25 countries under its WHO Emergency Use Listing (EUL). An additional 15 countries have met the requirements for nOPV2 use in the event of an outbreak. For more information on nOPV2, visit: www.polioeradication.org/nOPV2.

Security Council Press Statement on Afghanistan

The following Security Council press statement was issued today by Council President Ruchira Kamboj (India):

The members of the Security Council condemned in the strongest terms the heinous terrorist attack on innocent students and children at the religious school in Aybak, in the Samangan province, on 30 November. The attack resulted in the deaths of at least 20 students and children, and a dozen wounded.

The members of the Security Council expressed their deepest sympathy and condolences to the families of the victims, and they wished a speedy and full recovery to those who were injured.

The members of the Security Council called on all relevant parties to respect and ensure the safety and security of civilians, including children, and secure all educational facilities.

The members of the Security Council reaffirmed that terrorism in all its forms and manifestations constitutes one of the most serious threats to peace and security in Afghanistan, as well as in the world.

The members of the Security Council underlined the need to hold perpetrators, organizers, financiers and sponsors of these reprehensible acts of terrorism accountable and bring them to justice. They urged all States, in accordance with their obligations under international law and relevant Security Council resolutions, to cooperate actively with all relevant authorities in this regard.

The members of the Security Council reiterated that any acts of terrorism are criminal and unjustifiable, regardless of their motivation, wherever, whenever and by whomsoever committed.

[Holding International Organizations Accountable: Toward a Right to Justification in Global Governance?](#)

Abstract

This essay suggests that the accountability trends explored by Stian Øby Johansen and Gisela Hirschmann in their respective monographs should be viewed as indicating the emergence of a right to justification in global governance. Both Johansen and Hirschmann seek to advance the interdisciplinary conversation about the accountability of international organizations—Johansen by developing a normative framework assessing the quality of IO accountability mechanisms, and Hirschmann by seeking to identify the variables that shape the evolution of what she calls pluralist accountability. Building upon their analyses, I put forward a set of hypotheses about the procedural and substantive dimensions of the right to justification as well as the conditions for its consolidation in global governance.

Turkey: Parliament Adopts "Disinformation Law"

On October 13, 2022, Turkey's unicameral legislature, the Grand National Assembly of Turkey, adopted a law making it an offense to "overtly disseminate false information" under certain conditions. The law amends the Turkish Penal Code to add a new Article 217/A that provides for the offense. The amendments entered into force with the law's publication in the Official Gazette on October 18, 2022.

According to the translation provided by the Turkish government to the Council of Europe's Venice Commission, the text of the statute reads as follows:

Overtly Disseminating False Information to Mislead the Public

ARTICLE 217/A

(1) Any person who overtly disseminates false information contrary to the facts about the internal and external security, public order, and public health, with the motive exclusively to create distress, fear, and panic among public and in a manner conducive to disturb public peace, shall be sentenced to imprisonment from one to three years.

(2) If the offence is committed by concealing the true identity of the perpetrator or as part of the activities of an organized group, the penalty outlined in the preceding paragraph shall be increased by one-half.

The statute was criticized by many observers. The Venice Commission, which reviewed the draft law's conformity with the right to freedom of expression as enshrined in Article 10 of the European Convention on Human Rights, to which Turkey is party, issued an urgent opinion on the draft law on October 7, 2022, raising concerns about the law. The commission, while acknowledging that tackling disinformation was a legitimate social need, particularly criticized the law's use of terms such as "overtly disseminating" or "disturbance of public peace" as being too broad or vague, and expressed concern that the imposition of a prison sentence for the offense appeared to be a disproportionate measure that, together with the sanction enhancement for anonymous commission of the offense, would create a chilling effect and induce self-censorship. The commission also pointed out that in the original Turkish version, the subtitle of the article — unlike the term used in the body of the article — translated to "dissemination of misleading information" rather than "false information" which made the scope of the law unclear. The commission recommended that the government not enact the law. The

Media Freedom Representative of the Organization for Security and Co-operation in Europe (OSCE) also expressed concerns that “the vague definitions and broad scope of the newly proposed legislation can lead to arbitrary and politically motivated actions at the expense of free speech and media pluralism.”

The statute was criticized on the same or similar grounds by many Turkish commentators, including representatives of opposition parties; the Turkish Society of Criminal Law; Professor Yaman Akdeniz, a prominent information technology law scholar; and Rıza Türmen, an ex-judge of the European Court of Human Rights — all expressing serious concerns about the law’s potential chilling effect on journalistic practice and freedom of expression on the internet, especially on the eve of the 2023 general elections.

The government issued public statements defending the law. The deputy parliamentary group leader of the ruling party, the AKP, argued that the law was respectful of freedom of expression and targeted only coordinated disinformation campaigns against public order and peace, and that the scope was sufficiently circumscribed so that it would not have censorious effect. The chairman of the parliamentary commission on digital media, who is a member of the AKP, stated that the law was drafted in consultation with all relevant stakeholders and that its scope was not censorious.

The main opposition party, the CHP, filed a constitutional challenge before the Constitutional Court, claiming that the law violates constitutional rights and requesting its invalidation.

Significance
