This 33rd annual World Report summarizes human rights conditions in over 100 countries and territories worldwide in 2022. It reflects extensive investigative work that Human Rights Watch staff conducted during the year, often in close partnership with domestic human rights activists.

A New Model for Global Leadership on Human Rights

The obvious conclusion to draw from the litany of human rights crises in 2022—from Russian President Vladimir Putin’s deliberate attacks on civilians in Ukraine and Xi Jinping’s open-air prison for the Uyghurs in China to the Taliban’s putting millions of Afghans at risk of starvation —is that **unchecked authoritarian power leaves behind a sea of human suffering. But 2022 also revealed a fundamental shift in power in the world that opens the way for all concerned governments to push back against these abuses** by protecting and strengthening the global human rights system, especially when the actions of the major powers fall short or are problematic.

We have witnessed world leaders cynically trading away human rights obligations and accountability for human rights abusers in exchange for seeming short-term political wins. US presidential candidate Joe Biden’s principled pledge to make Saudi Arabia a “pariah state” over its human rights record was eviscerated once he was in office and facing high gas prices by his bro-like fist bump with Saudi Arabia’s Mohammed Bin Salman. And the Biden administration, despite its rhetoric about prioritizing democracy and human rights in Asia, has tempered criticism of abuses and increasing authoritarianism in India, Thailand, the Philippines, and elsewhere in the region for security and economic reasons, instead of recognizing that all are linked.

Of course, these kinds of double standards are not solely the purview of global superpowers. Pakistan has supported the United Nations high commissioner for human rights’ monitoring of abuses in Muslim-majority Kashmir, but owing to its close relationship with China, has turned its back on possible crimes against humanity against Uyghur and other Turkic Muslims in Xinjiang. Pakistan’s hypocrisy is especially glaring given its coordinator role of the 57-member Organisation of Islamic Cooperation.

Human rights crises do not arise from nowhere. Governments that fail to live up to their legal obligations to protect human rights at home sow the seeds of discontent, instability, and ultimately crisis. Left unchecked, the egregious actions of abusive governments escalate, cementing the belief that corruption, censorship, impunity, and violence are the most effective tools to achieve their aims. Ignoring human rights violations carries a heavy cost, and the ripple effects should not be underestimated.

But in a world of shifting power, we also found opportunity in preparing our 2023 World Report, which examines the state of human rights in nearly 100 countries. Each issue needs to be understood and addressed on its own merits, and each requires leadership. **Any state that recognizes the power that comes from working in concert with others to affect human rights change can provide that leadership. There is more space, not less, for governments to stand up and adopt rights-respecting plans of action...**



Canada – Indigenous Peoples Settlement

Settlement agreement reached for Band class litigation

January 21, 2023 — Vancouver, BC — *Crown–Indigenous Relations and Northern Affairs Canada* Today, Band class representatives former Chief Shane Gottfriedson and former Chief Garry Feschuk, along with the Honourable Marc Miller, Minister of Crown-Indigenous Relations, announced that **Canada has signed an agreement with the Representative Plaintiffs who represent the 325 bands that have opted into the Band class litigation.**

In this settlement, Canada will provide \$2.8 billion to be placed in a not-for-profit trust, independent of the Government. Canada is committed to addressing the collective harm caused by the residential schools system and the loss of language, culture, and heritage – through this settlement guided by the Four Pillars developed by the Representative Plaintiffs.

The Four Pillars include:

- the revival and protection of Indigenous languages,
- the revival and protection of Indigenous cultures,
- the protection and promotion of heritage, and
- wellness for Indigenous communities and their members.

This resolution aims to revitalize Indigenous education, culture, and language – to support Survivors in healing and reconnecting with their heritage.

The funding disbursement plan, developed by the plaintiffs, outlines an initial amount of \$200,000 for each band class member to support the development of a funding proposal that reflects the objectives and purposes of the Four Pillars. These proposals will be reviewed and used to support the disbursement of the Initial Kick-Start Funds, totaling \$325 million. Each Band class member will receive a share of annual investment income that is available.

Further information on the terms of the settlement will be publicly available over the next month as part of the broader notice plan. **The parties are expected to appear before the Federal Court on February 27, 2023, to seek approval of the terms of the settlement. The Court will consider whether the settlement is fair, reasonable and in the best interest of the class members.**

Addressing historical wrongs and the painful legacy still suffered by Survivors, their families and communities is at the heart of reconciliation, and is essential to renewing and building relationships with Indigenous Peoples.

The pledge includes 10 key commitments all signatories have made to embed health equity principles throughout their operations, workforce and guiding philosophies. It marks the beginning of an historic journey to making health equity an integral part of business strategies globally and an important step towards a world without health disparities.

The Zero Health Gaps Pledge is part of the Global Health Equity Network, which brings together key stakeholders from the public and private sectors to advance a collective vision of zero health gaps, in line with the UN Sustainable Development Goals. This innovative pledge is a public statement from its members declaring their commitment to take concrete steps to improve health equity across sectors and geographies and to help build a resilient and inclusive global economy that drives value for all... the pledge is a direct response to the persistent and growing global health disparities between and within countries. The difference in average life expectancy at birth between high- and low-income countries is glaring at 78 and 64 years respectively. At the most extreme, Japan and the Central African Republic have a difference in average life expectancy of over 30 years. Global climate and health crises, including the COVID-19 pandemic, have heightened both the severity of these inequities and the potential consequences of inaction. Stewardship of Science – Integrity

[OSTP Releases Framework for Strengthening Federal Scientific Integrity Policies and Practices](#)

U.S. White House Office of Science and Technology Policy (OSTP)

January 12, 2023

Today, the White House Office of Science and Technology Policy (OSTP) released [A Framework for Federal Scientific Integrity Policy and Practice](#), a roadmap that will help strengthen scientific integrity policies and practices across the federal government.

This framework builds on the assessment of federal scientific integrity policies and practices described in the January 2022 report, [Protecting the Integrity of Government Science](#), and draws from extensive input from federal agencies, as well as from across sectors, including academia, the scientific community, public interest groups, and industry. It has several key components that federal departments and agencies will use to improve scientific integrity policies and practices, including:

- **A consistent definition of scientific integrity for all federal agencies**
- **A model scientific integrity policy to guide agencies as they build and update their policies**
- **A set of tools to help agencies regularly assess and improve their policies and practices**

The framework requires all agencies to designate a scientific integrity official, and agencies that fund, conduct, or oversee research to designate a chief science officer, and it establishes [the National Science and Technology Council \(NSTC\) Subcommittee on Scientific Integrity](#) to oversee implementation of the framework, and evaluate agency progress...

Executive Summary

The 2021 Presidential Memorandum on Restoring Trust in Government Through Scientific Integrity and Evidence-Based Policymaking charges OSTP to

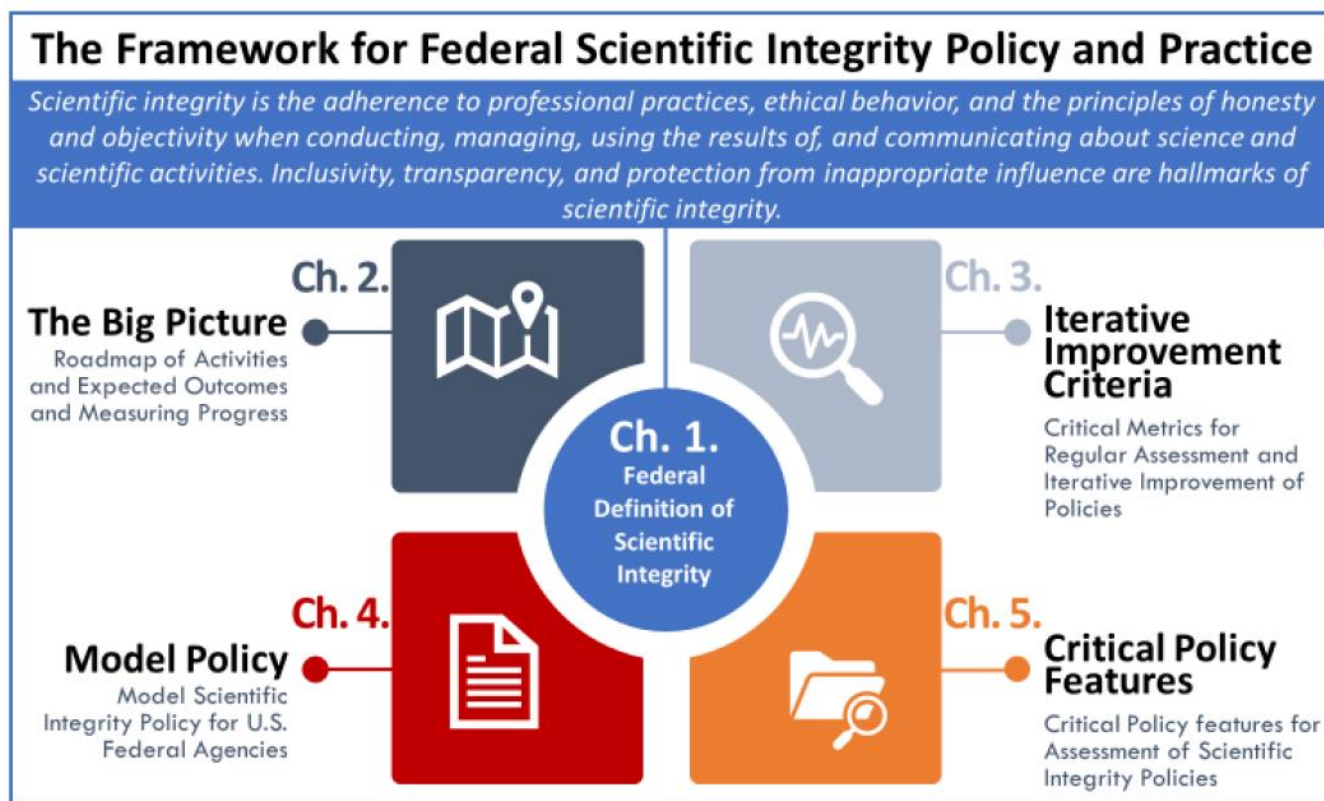
- (1) review agency scientific integrity policy effectiveness and
- (2) to develop a framework for regular assessment and iterative improvement of agency scientific integrity policies and practices (Framework).

This document builds on the review published in January 2022 by the National Science and Technology Council (NSTC) entitled [Protecting the Integrity of Government Science](#), which identified good agency practices on scientific integrity and areas in need of consistency across agencies. This Framework includes key resources for agencies as they work to develop and improve scientific integrity policies, practices, and culture. **The Framework reflects input from the interagency Scientific Integrity Task Force and other key Federal officials, and includes considerations from public input.**

To foster regular assessment and iterative improvement at Federal agencies, the Framework includes several components, including a first-ever Government-wide definition of scientific integrity, a roadmap of activities and outcomes to achieve an ideal state of scientific integrity, a Model Scientific Integrity Policy, as well as critical policy features and metrics that OSTP will use to iteratively assess agency progress.

The Framework also includes a charter for the newly established NSTC Subcommittee on Scientific Integrity. This subcommittee has been chartered by the NSTC Committee on Science to assist OSTP in assessment and iterative improvement of agency and EOP component scientific integrity policies, practices, and culture; provide advisory responses to agency requests for another agency to review their internal scientific integrity policies and processes, such as inquiries related to senior-level officials, political appointees, or scientific integrity officials; and serve as a community of practice for Federal agency scientific integrity officials and staff.

The goal of this Framework is to assist agencies across the Federal Government as they take next steps together to strengthen, implement, and institutionalize scientific integrity policy, practice, and culture...

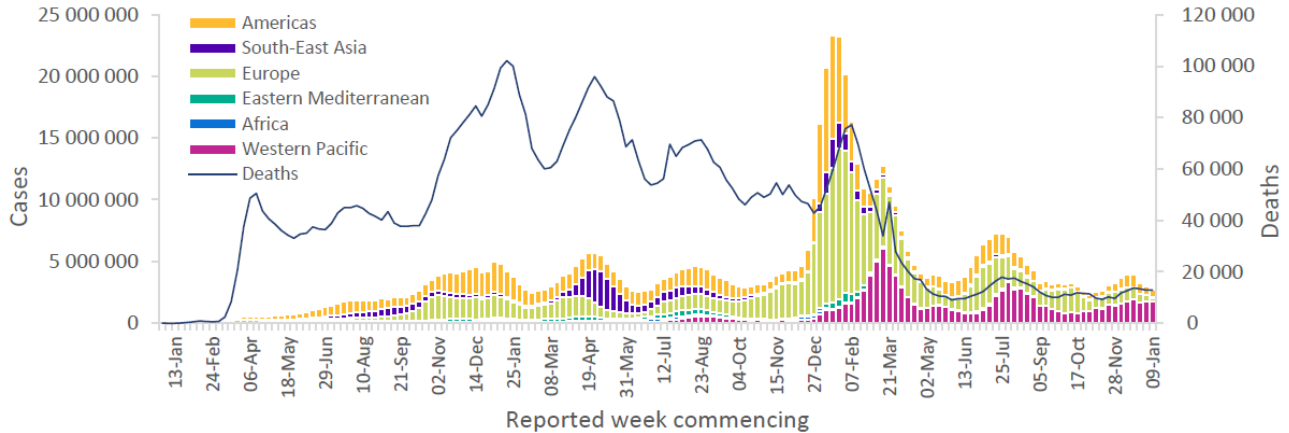
Weekly epidemiological update on COVID-19 - 19 January 2023

Overview

Globally, nearly 2.8 million new cases and over 13 000 deaths were reported in the week of 9 to 15 January 2023. In the last 28 days (19 December 2022 to 15 January 2023), nearly 13 million cases and almost 53 000 new deaths were reported globally – a decrease of 7% and an increase of 20%, respectively, compared to the previous 28 days. As of 15 January 2023, over 662 million confirmed cases and over 6.7 million deaths have been reported globally...

China says COVID outbreak has infected 80% of population

BEIJING, Jan 21 (Reuters) - The possibility of a big COVID-19 rebound in China over the next two or three months is remote as 80% of people have been infected, a prominent government scientist said on Saturday.

The mass movement of people during the ongoing Lunar New Year holiday period may spread the pandemic, boosting infections in some areas, but a second COVID wave is unlikely in the near term, Wu Zunyou, chief epidemiologist at the China Center for Disease Control and Prevention, said on the Weibo social media platform.

Hundreds of millions of Chinese are travelling across the country for holiday reunions that had been suspended under recently eased COVID curbs, raising fears of fresh outbreaks in rural areas less equipped to manage large outbreaks.

China has passed the peak of COVID patients in fever clinics, emergency rooms and with critical conditions, a National Health Commission official said on Thursday.

Nearly 60,000 people with COVID had died in hospital as of Jan. 12, roughly a month after China abruptly dismantled its zero-COVID policy, according to government data.

But some experts said that figure probably vastly undercounts the full impact, as it excludes those who die at home, and because many doctors have said they are discouraged from citing COVID as a cause of death.

GENEVA (20 January 2023) - UN High Commissioner for Human Rights Volker Türk today launched an appeal for US\$452 million to assist funding for his Office's critical work in 2023, and "to bring human rights to life in every part of the world".

"Without human rights there can be no enduring peace. No sustainable development. No justice," he said at the launch of the annual appeal for voluntary funds from Member States and private donors. Türk said he hoped the 75th anniversary of the Universal Declaration of Human Rights and the UN Charter would encourage an increase in funding, and enable his Office to strengthen capacity to meet the needs and requests of States and partners.

The Inter-American Development Bank (IDB) approved a \$260 million loan to Brazil to improve housing in vulnerable neighborhoods of Recife. The city is the country's ninth largest, and also one of its most threatened by climate change because of its geography. The program aims to give low-income communities more access to infrastructure, urban facilities and social services.

A user-centered design (UCD) process was used to adapt the intervention, and CAG members participated in codesign sessions as design team members. The CAG members supported UCD activities with Rohingya women and girls seeking family planning (FP),

menstrual regulation (MR), and post abortion care (PAC) services, service providers, and community health workers. The CAG members met four times during the project period to ensure adaptation of the ARCHES intervention in the humanitarian context and smooth implementation of the intervention to reduce RC and IPV.

January 18, 2023 — The clinical trial began in 2019 and involved 3,900 volunteers.

An investigational HIV vaccine regimen tested among men who have sex with men (MSM) and transgender people was safe but did not provide protection against HIV acquisition, an independent data and safety monitoring board (DSMB) has determined. The HPX3002/HVTN 706, or "Mosaico," Phase 3 clinical trial began in 2019 and involved 3,900 volunteers ages 18 to 60 years in Europe, North America and South America. Based on the DSMB's recommendation, the study will be discontinued. Participants are being notified of the findings, and further analyses of the study data are planned.

Janssen Vaccines & Prevention B.V., part of the Janssen Pharmaceutical Companies of Johnson & Johnson, sponsored the Mosaico study with funding support from the National Institute of Allergy and Infectious Diseases (NIAID), part of the National Institutes of Health. The trial was conducted by the NIAID-funded HIV Vaccine Clinical Trials Network, based at the Fred Hutchinson Cancer Research Center in Seattle. The U.S. Army Medical Research and Development Command provided additional study support...

SEATTLE, WA (January 16, 2023) – In his [annual letter](#) published today, Bill & Melinda Gates Foundation CEO Mark Suzman announced **the foundation will spend US\$8.3 billion this year** to continue its work fighting poverty, disease, and inequity. He also shared examples of how the foundation uses its resources, voice, and convening power to call attention to and help find solutions for problems that otherwise might be neglected.

The budget—the largest in the foundation's history—is a response to multiple crises that threaten to stall or reverse global progress on the Sustainable Development Goals since the start of the COVID-19 pandemic. These include war, economic turmoil, climate-related disasters, and large decreases in vaccinations for preventable infectious diseases, all of which have taken a significant toll on the world's poorest people. The board of trustees' approval of the budget puts the foundation on track to meet its commitment to reach an annual payout of US\$9 billion by 2026—and represents a 15% increase over the 2022 forecasted payout.

"This is the toughest period for global health and development in recent memory, but in some ways, it's also the reason we exist," Suzman said. "To help meet the great needs ahead, we are doubling down on our commitment to our core mission: ensuring everyone can live a healthy and productive life."...

The relationship between armed groups and local populations is often portrayed as either predatory or symbiotic. However, local populations are not just passive actors in conflict and armed groups do not only exploit and abuse civilians. Community engagement with armed groups happens discreetly and, significantly, before any recognised mediation or negotiation processes. As the number of protracted, non-international armed conflicts, as well as the number and range of actors involved in them, increases, it is essential that protection actors better understand the interactions between communities and armed actors.
