The purposes and principles embedded in the United Nations Charter are not a matter of convenience. They are not merely words on paper. They are at the core of who we are. They reflect the driving mission of our United Nations. And they exist precisely to address any grievance — whatever it may be.

One year ago, I sat in this Council and urged: "In the name of humanity do not allow to start in Europe what could be the worst war since the beginning of the century, with consequences not only devastating for Ukraine, not only tragic for the Russian Federation, but with an impact we cannot even foresee in relation to the consequences for the global economy."

I said then that we must give peace a chance. But peace has had no chance. War has ruled the day. The Russian invasion of Ukraine is a blatant violation of the United Nations Charter and international law. It has unleashed widespread death, destruction and displacement. Attacks on civilians and civilian infrastructure have caused many casualties and terrible suffering.

The Office of the High Commissioner for Human Rights has documented dozens of cases of conflict-related sexual violence against men, women and girls. Serious violations of international humanitarian and human rights law against prisoners of war — and hundreds of cases of enforced disappearances and arbitrary detentions of civilians — were also documented.

Life is a living hell for the people of Ukraine. An estimated 17.6 million people — nearly 40 per cent of the population of Ukraine — require humanitarian assistance and protection. The crisis has erased 30 per cent of pre-war jobs.

The World Food Programme estimates that nearly 40 per cent of Ukrainians are unable to afford or access enough food. The war has sparked a displacement crisis not seen in Europe in decades. More than 8 million Ukrainian refugees have been recorded across Europe, in addition to an estimated 5.4 million people who have been internally displaced. More than half of all Ukrainian children have been forced from their homes — with unaccompanied and separated children facing grave risks of violence, abuse, and exploitation.

Vital infrastructure is under fire — water, energy and heating systems have been destroyed in the depths of a freezing winter. The World Health Organization has verified over 700 attacks on health-care facilities. More than 3,000 schools and colleges have been damaged or destroyed. Millions of students have had their education severely disrupted. Less measurable — but no less important — is the devastating impact of months of displacement and bombardment on the mental health of Ukrainians. **Nearly 10 million people, including 7.8 million children, are at risk of acute post-traumatic stress disorder. And make no mistake, the Russian Federation is also suffering the deadly consequences.**

We need peace — peace in line with the United Nations Charter and international law. As we work for peace, we will continue calling for action on many fronts. Protection of civilians must remain the top priority. **Attacks on civilians and civilian infrastructure must stop. The use of explosive weapons with wide-area effects in populated areas — in towns, cities and villages — must end. Safe and unimpeded humanitarian access for life-saving assistance must be ensured.**

We must also invest in Ukraine's recovery and reconstruction. At the request of the Ukrainian Government and on behalf of the United Nations system, the United Nations Development Programme is co-leading an assessment of damage to energy infrastructure, jointly with the World Bank.

Since the start of the war, the International Atomic Energy Agency has supported Ukraine to ensure the safety and security of its 15 operating reactors at four nuclear plants, including Europe's largest nuclear power plant in Zaporizhzhia. We continue to urge all parties to swiftly agree and implement a nuclear safety and security protection zone at Zaporizhzhia Nuclear Power Plant to avoid a serious accident with potentially disastrous consequences. Veiled threats to use nuclear weapons in the context of the conflict have spiked nuclear risks to levels not seen since the darkest days of the cold war. These threats are unacceptable.

Progress continues to be made under the Black Sea Grain Initiative, an agreement brokered with the parties by the United Nations and the Government of Türkiye. More than 20 million metric tons of foodstuffs have now been safely reconnected to global supply chains on more than 700 ships, helping to bring down prices around the world.

I want to underscore the importance of all parties remaining engaged in this initiative and reiterate our call for it to be extended beyond March 2023. The United Nations is firmly committed to working to remove remaining obstacles to Russian food and fertilizer exports, including ammonia. These exports

are essential to our broader efforts to bring down prices and ease food insecurity around the globe. Both efforts demonstrate that international cooperation is essential, valuable and possible — even in the midst of conflict.

Over the past year, this Council has held more than 40 debates on Ukraine. The guns are talking now, but in the end we all know that the path of diplomacy and accountability is the road to a just and sustainable peace. Peace in line with the United Nations Charter and international law, and yesterday's resolution of the General Assembly.

We must prevent further escalation. We must all encourage every meaningful effort to end the bloodshed and, at long last, give peace a chance.

[**No Time to Lose, Secretary-General Tells Emergency Session on Ukraine, Urging Action for Ending Russian Federation Invasion, Fully Supporting \\$5.6 Billion Humanitarian Appeal**](#)

The one-year mark of Russia's invasion of Ukraine stands as a grim milestone — for the people of Ukraine and for the international community. **That invasion is an affront to our collective conscience. It is a violation of the United Nations Charter and international law. It is having dramatic humanitarian and human rights consequences. And the impact is being felt far beyond Ukraine.**

As I said from day one, Russia's attack on Ukraine challenges the cornerstone principles and values of our multilateral system. The United Nations Charter is unambiguous: "All members shall refrain in their international relations from the threat or use of force against the territorial integrity or political independence of any state, or in any other manner inconsistent with the Purposes of the United Nations."

The General Assembly has addressed, in the clearest terms, the attempt by the Russian Federation to illegally annex four regions of Ukraine — Kherson, Zaporizhzhia, Donetsk and Luhansk. In doing so, the Assembly reaffirmed the longstanding principles of international law contained in its landmark Friendly Relations Declaration of 1970. Namely, that "the territory of a State shall not be the object of acquisition by another State resulting from the threat or use of force", and that "no territorial acquisition resulting from the threat or use of force shall be recognized as legal".

The position of the United Nations is unequivocal: We are committed to the sovereignty, independence, unity and territorial integrity of Ukraine, within its internationally recognized borders...

[**Hours Before Ukraine Conflict Enters Second Year, General Assembly Adopts Resolution Demanding Russian Federation Withdraw Military Forces, Adjourning Emergency Session**](#)

The General Assembly adjourned its emergency special session on Ukraine today on the eve of the first anniversary of the Russian Federation's invasion of that country, **adopting a resolution that underscored the need to urgently reach peace, demanded that the Russian Federation withdraw its military forces and emphasized the need to ensure accountability for crimes committed on Ukraine's territory.**

The text — “*Principles of the Charter of the United Nations underlying a comprehensive, just and lasting peace in Ukraine*”— was **adopted by a recorded vote of 141 in favour to 7 against (Belarus, Democratic People’s Republic of Korea, Eritrea, Mali, Nicaragua, Russian Federation and Syria), with 32 abstentions.**

By its terms, the General Assembly underscored the need to reach — as soon as possible — a comprehensive, just and lasting peace in Ukraine in line with the principles of the Charter of the United Nations, also calling on Member States and international organizations to redouble support for diplomatic efforts towards this end.

Further, reaffirming its commitment to the sovereignty, independence, unity and territorial integrity of Ukraine within its internationally recognized borders — extending to its territorial waters — the Assembly reiterated its demand that the Russian Federation immediately, completely and unconditionally withdraw its military forces from Ukraine’s territory and called for a cessation of hostilities.

The Assembly also demanded that the treatment by the parties to the armed conflict of all prisoners of war be in accordance with certain international conventions, and called for the complete exchange of such prisoners, the release of all unlawfully detained persons and the return of all internees and civilians forcibly transferred and deported. **Through the text, the Assembly called for full adherence by such parties to their obligations under international humanitarian law to spare the civilian population and civilian objects; to ensure safe, unhindered humanitarian access to those in need; and to immediately cease attacks on Ukraine’s critical infrastructure.**

The resolution also saw the Assembly emphasize the need to ensure accountability for the most serious crimes under international law committed on Ukraine’s territory through appropriate, fair and independent investigations and prosecutions at the national or international level. Further, it urged all Member States to cooperate to address the war’s global impact on food security, energy, finance, the environment and nuclear security and safety...

Global Governance – Impunity

[The Atlas of Impunity](#)

The Atlas of Impunity is a joint effort by David Miliband and his staff and the Chicago Council on Global Affairs, with analytical support from Eurasia Group’s Geostrategy team. It was made possible by generous financial support from the Open Society Foundations and the MacArthur Foundation.

Impunity is the exercise of power without accountability, which becomes, in its starkest form, the commission of crimes without punishment. In a phrase, impunity is the idea that “the law is for suckers,” a notion that human rights leaders fear is on the rise in political institutions around the world. From behavior in conflict to economic exploitation, from environmental degradation to democratic backsliding, the battle between impunity and accountability is a critical lens for understanding what is happening in the world.


The *Atlas of Impunity* is a quantitative assessment of this holistic definition of impunity, measured by independent indicators across five sites in society.

The Atlas scores and ranks the level of impunity in 163 countries and provides partial, indicative scoring for another 34. Above all, the Atlas is intended to provide a practical and accessible tool to draw attention to abuses of power and press policymakers for change. The report and accompanying data aim to shine a light on the norms and practices that perpetuate impunity and hinder accountability around the world.



Countries are scored on a scale of 0 to 5, with the countries exhibiting the greatest level of impunity scoring closer to 5, and the countries with the lowest level of impunity scoring closer to 0.

Key Findings

- **The legacy of colonialism and the slave trade is correlated with higher impunity scores.** Nearly all the 20 countries with the highest levels of impunity are former colonies or countries affected by colonialism. Similarly, about one-third of the 30 worst-ranked countries were affected by the slave trade. However, while impunity scores are informed by circumstance, they can be molded by policy choices: some countries that have suffered from the historical legacy of slavery and colonization such as Ghana and Senegal, score well on the Atlas.
- **The US is closer to the median than top performers** and ranks higher on impunity than both Hungary and Singapore. Indeed, most of the world's great regional powers—including China, Russia, Brazil, India, or Iran—perform relatively poorly compared to economic and geographic peers.
- **Environmental degradation is where impunity continues to thrive**, even among otherwise accountable societies. Canada, which is one of the best performing countries on the Atlas and traditionally scores well on similar indices, is only moderately better than the mean in terms of environmental degradation. India, China, Russia, and the US—all among the largest greenhouse gas (GHG) emitters globally—place 20th, 70th, 78th, and 101st, respectively.
- **Violence against women and gender-based discrimination is a global problem.** This type of impunity negatively affects the human rights and conflict and violence scores of theocracies such as Afghanistan. But it also affects some liberal democracies, states in conflict such as Syria, and peaceful countries including South Korea.
- **Human rights are being abused and accountability is falling within democracies.** Certain democratic countries that perform well on the unaccountable governance dimension perform substantially worse on the abuse of human rights. In fact, Singapore, which is not a full-fledged liberal democracy, ranks better on unaccountable governance than certain democracies. Weaker democracies such as Mexico, Kenya, and Ukraine are scored on par with non-democratic countries including Jordan and the UAE.



Climate

WASHINGTON, D.C. | February 24, 2023 — The U.S. Department of State, The Rockefeller Foundation, and the Bezos Earth Fund today held the first meeting of the High-Level Consultative Group (HLCG) providing input on the design of the Energy Transition Accelerator (ETA), **a joint initiative to catalyze private capital to accelerate the transition from fossil fuel to clean power in developing countries...**

U.S. Special Presidential Envoy for Climate John Kerry, The Rockefeller Foundation President Dr. Rajiv J. Shah, and Bezos Earth Fund Chief Executive Officer Dr. Andrew Steer hosted a virtual meeting of the HLCG, a panel of intergovernmental, private sector, and civil society leaders, as well as other experts and stakeholders, from Africa, Asia, Europe, Latin America, and the United States...

The aim of the ETA is to help keep a 1.5°C limit on warming within reach by driving private investment in the implementation of energy transition strategies that deliver deeper,

earlier greenhouse gas reductions in developing countries. Annual clean energy investment must triple to \$4.2 trillion by 2030 to keep 1.5°C within reach, according to the International Energy Agency, with more than half of that investment in emerging and developing economies.

The ETA will seek to leverage the growing demand for high-quality carbon credits to scale up finance to accelerate the deployment of clean power and the retirement of fossil fuel assets in developing countries. In addition to reducing emissions, **finance generated by the ETA will support developing countries in expanding clean energy access and creating jobs and economic growth. The ETA also will generate new finance for adaptation efforts in vulnerable countries.**

HLCG participants were invited to provide input on a preliminary ETA framework, which would include a jurisdictional-scale carbon crediting standard, a coalition of private sector and sovereign government buyers, a set of developing country host jurisdictions, criteria to ensure environmental integrity in the generation and use of credits, and just transition provisions addressing needs such as job creation, worker training, revenue sharing, and energy access.

In addition to ongoing input from the High-Level Consultative Group, the partners will consult with a wider array of government, business, and civil society stakeholders and will provide opportunities for broader input, including briefings and listening sessions.

The Department of State, The Rockefeller Foundation, and the Bezos Earth Fund are **collaborating for the purpose of developing the Energy Transition Accelerator as an independent initiative**. In designing the ETA, the partners will seek broad alignment with evolving best-practice standards, including those of the Science Based Targets Initiative (SBTi), the Voluntary Carbon Markets Initiative (VCMI), and the Integrity Council for the Voluntary Carbon Market (IC-VCM)...

[‘Science thrives best through international collaboration’ – Jeremy Farrar on ten years at Wellcome](#)

It is remarkable to look back on the role of science in enabling extraordinary advances in global health over the last decade – science that Wellcome has supported with researchers and partners around the world. Though the challenges become ever greater and more urgent, I am optimistic that we are living in an era of significant and long-enduring innovation.

Ebola vaccine showed science at its best

I joined Wellcome as Director in 2013, following almost 18 years in Viet Nam researching infectious diseases. I lived and worked through avian flu, SARS-1, epidemics of drug-resistant typhoid and the emergence of HIV. I witnessed first-hand the effects of diseases such as dengue, TB and malaria on local communities. The world had yet to see the shocking impacts of Ebola in West Africa, Zika in South America, and SARS-CoV-2 everywhere.

At the time, Wellcome's commitment to cutting-edge discovery research – and major activities like the Wellcome Sanger Institute, Francis Crick Institute and Wellcome's Africa and Asia Programmes – had already led to breakthroughs in the human genome, neuroscience, social sciences and much more. Since then, our ambitions and horizons have grown at a breathtaking scale that even I could not have dared to dream.

There are countless moments where I am proud of Wellcome's contribution to progress. Our response to the heart-breaking west African Ebola epidemic of 2014-16 stands out. The international community initially responded far too slowly and the epidemic spread across the region, devastating communities – the effects are still felt today. But progress was made with the development of the critically important Ebola vaccine.

This was an example of science at its best. Not so much because of the astonishing achievement of creating that vaccine, but because communities dared to ask: 'what if?'. What if, during a crisis, we carried out the research needed to progress promising, life-saving science?

There was an appreciation for community ownership, the social sciences and the underlying trust to conduct research in a rapidly developing epidemic, to bring it to an end faster and save lives. This is a position that Guinea, Sierra Leone and Liberia along with partners in the region, WHO, Norway and Wellcome strongly advocated for, put funding behind and implemented.

Not all the lessons the world needed to heed on infectious disease were learnt from that epidemic, but the effective vaccine and treatment studies have saved thousands of lives since. This success is testament to local communities, health workers, researchers and industry.

I can also confidently say that this led to a transformational change to how we approach any disease outbreak, not just Ebola. It led to the creation of CEPI, which Wellcome proudly co-founded in 2016 and the set-up of the WHO R&D Blueprint. It led to a much quicker response including vaccination in subsequent Ebola epidemics in the Democratic Republic of Congo, and a much faster response to the Covid-19 pandemic in the form of the RECOVERY and Solidarity trials, which provided the evidence on what vaccines and treatments work and what did not.

By keeping patients and communities at the centre and daring to be bold and ambitious, we can make a meaningful change to health.

Wellcome's resource and role

Thanks to our world-class investments team, Wellcome's endowment has grown from £15 billion when I joined to £38 billion today, allowing us to more than double the amount we spend annually on research. Over the next ten years to 2033, Wellcome is committed to spending £16 billion supporting outstanding science.

Philanthropy cannot and should not replace the role of government or become the establishment. But Wellcome has the resource to initiate change as well as the independence and transparency that can be harnessed to push boundaries where others may not be able to.

It is this outlook that helped us refresh our strategy. We're now better placed to support discovery, clinical and public health research that will transform our understanding of health, wellbeing and life itself. And we're supporting science to solve the global health challenges of our changing climate, infectious disease outbreaks and mental health problems through dedicated programmes.

A vision for the future

The biggest advances to improve health are rarely, if ever, lone events or strokes of luck. Building on years of painstaking work, scientific success is only possible through iteration and learning. Science thrives best through international collaboration. We live in a highly connected world and we must look beyond our own borders, working together to benefit as many lives as possible. We all owe it to ourselves and to future generations to break down barriers.

It has been a unique honour and great pleasure to lead Wellcome for the last decade and I leave taking with me enormous pride in what we have achieved together.

The mission to improve health has never been more focused in the hands of the amazing teams that make Wellcome what it is today.

Paul Schreier, Wellcome's Chief Operating Officer, has been appointed interim Chief Executive Officer, with effect from 25 February 2023. Jeremy Farrar will take up the position of Chief Scientist of the World Health Organization later this year.



Labour Rights – Crises, Sustainable Development

Labour rights as human rights are essential to fight crises

A joint statement by the Committee of Experts on the Application of Conventions and Recommendations of the International Labour Organization and eight United Nations Human Rights Treaty Bodies marks the third anniversary of the UN Secretary-General's Call to Action for Human Rights.

GENEVA (ILO News) – The ILO Committee of Experts on the Application of Conventions and Recommendations (CEACR) and the Chairpersons of eight UN Human Rights Treaty Bodies have issued **a joint statement reaffirming the importance of universal human rights and international labour standards in addressing crises and sustainable development.**

The statement re-affirms the responsibility of the UN Human Rights Treaty Bodies and the ILO Committee of Experts to promote within their respective mandates, **“the effective fulfilment of human rights, including labour rights, especially for those at risk of being left behind.”**

It calls upon all stakeholders, without exception, to maximize efforts for the effective implementation of recommendations from the Human Rights Treaty Bodies and the Committee of Experts. The Chairpersons of the Human Rights Treaty Bodies and the Committee of Experts also undertake to join their efforts for the promotion of all human rights – including international labour standards – through joint analyses, concerted action and periodic thematic meetings.

The statement was issued on the third anniversary of the UN Secretary-General's Call to Action for Human Rights. Human Rights Treaty Bodies joining the statement:



Weekly epidemiological update on COVID-19 - 15 February 2023

Overview

Globally, nearly 5.3 million new cases and over 48 000 deaths were reported in the last 28 days (23 January to 19 February 2023), a decrease of 89% and 62%, respectively, compared to the previous 28 days. As of 19 February 2023, over 757 million confirmed cases and over 6.8 million deaths have been reported globally.

STATEMENT: Ukraine conflict one year on

Blue Shield Statement on Conflict in Ukraine

... We hear regular reports of damage to all types of heritage from shelling and looting. We are concerned that fighting in urban settings entails particularly grave risks for civilians and their heritage. We ask all combatants to remember their obligations to protect civilians and civilian infrastructures, including cultural property; not to use any cultural property or its immediate surroundings, and to avoid attacks against it unless military necessity imperatively requires it. Parties to the conflict must do everything feasible to verify that the objectives to be attacked are not cultural property; must take all feasible precautions to minimise damage; and must refrain from launching attacks which may be expected to cause excessive damage. We particularly highlight the use of explosive weapons in populated areas, which have a high likelihood of indiscriminate effects, directly risking civilians and their heritage. Further, as High Contracting Parties to the 1954 Hague Convention and its First Protocol, those involved in the conflict have agreed to prevent pillage, looting, and vandalism, not to requisition cultural property, and not to conduct reprisals against it.

The Blue Shield stands ready to assist anyone involved in the conflict to protect heritage in Ukraine, and to provide any assistance possible towards a resolution to the conflict.

In 2021, the OECD's Development Assistance Committee (DAC) failed to agree on how to count donations of excess vaccine doses as ODA. Instead, they suggested a guideline price of US\$6.72, and implemented 'safeguards' to satisfy those members who didn't think excess vaccine donations should count as ODA at all. Now that full data for 2021 is available, this blog explores the differences in how donors reported, and finds that some of the safeguards were ignored and that a range of prices have been used. For 2022 data, it appears that a new, similar price (US\$6.66) has been agreed. It would be simpler and more justifiable – and help to preserve the integrity of ODA – to exclude excess vaccine donations altogether, as some DAC members have argued for since the issue arose.

This week's selection reminded us that the nature and scope of the humanitarian crisis is far from something we have addressed, even to a minimal degree.

For example, asylum seekers in the US are fighting the state for humanitarian recognition, Africa is holding elections amid the impact of the humanitarian crisis; and earthquake response reaches Syria as humanitarian crisis continues. Furthermore, the ICRC's changing role in international armed conflicts is taking new shapes, while decarbonisation and conflict resolution explore the overlap between the two as the world clamors for clean energy.

The limits of the call for peace in Ukraine become more visible and obvious as the invasion reaches a full year.

Two publications showed us unresolved conceptual issues. In light of the ALNAP 2022 state of the humanitarian system, one post asked whether a systems approach can improve the system per se, while another suggested a vulnerability-focused approach for consideration.

Child abuse is so common that it has become a subspecialty in pediatrics. Indeed, children are 40 times more likely to be confirmed victims of abuse or neglect than to be diagnosed with cancer. "Upstream" obligations to help prevent abuse and neglect of children accompany clinicians' "downstream" obligations as mandatory reporters, first responders, secondary illness and injury documentarians, and gatherers of forensic evidence. Since clinicians are also key communicators with children, perpetrators, parents, and colleagues during or following clinical encounters, how well they promote short- and long-term healing among persons who are or were victims of child abuse or neglect is often a function of

how well they express trauma-informed care values in practice. This theme issue also considers how clinicians should best promote healing among persons, including themselves, who struggle to manage their own psychological and emotional secondary trauma responses when taking care of children who are abused and neglected.

Summary

Decades of research have identified genetic factors and biochemical pathways involved in neurodegenerative diseases (NDDs). We present evidence for the following eight hallmarks of NDD: pathological protein aggregation, synaptic and neuronal network dysfunction, aberrant proteostasis, cytoskeletal abnormalities, altered energy homeostasis, DNA and RNA defects, inflammation, and neuronal cell death. This study examines practices related to trial registration and results submission in ClinicalTrials.gov and publication of pediatric clinical trials funded by the National Institutes of Health.

Discussion

Among NIH-funded pediatric trials, lack of prospective trial registration and failure to submit trial results to ClinicalTrials.gov was common, consistent with findings from studies examining registration and results dissemination across broad groups of trials.^{4,5} In addition, almost half of pediatric trials did not have results published 4 years after completion of NIH funding.

Study limitations include that not all trial publications may have been identified and that the analyses relied on publicly available data that could not be verified. Additionally, certain trials may have been published beyond the follow-up period examined.

The NIH recently announced plans to increase enforcement activities for trial registration and reporting and to verify adherence to these requirements prior to issuing subsequent awards to NIH-funded investigators.⁶ While there is an ethical obligation for timely dissemination of all research involving human participants, this responsibility warrants particular consideration when trials are supported by public funds and enroll pediatric patients.

Summary

The COVID-19 pandemic has exposed faults in the way we assess preparedness and response capacities for public health emergencies. Existing frameworks are limited in scope, and do not sufficiently consider complex social, economic, political, regulatory, and ecological factors. One Health, through its focus on the links among humans, animals, and ecosystems, is a valuable approach through which existing assessment frameworks can be analysed and new ways forward proposed. Although in the past few years advances have been made in assessment tools such as the International Health Regulations Joint External Evaluation, a rapid and radical increase in ambition is required. To sufficiently account for the range of complex systems in which health emergencies occur, assessments should consider how problems are defined across stakeholders and the wider sociopolitical environments in which structures and institutions operate. Current frameworks do little to consider anthropogenic factors in disease emergence or address the full array of health security hazards across the social–ecological system. A complex and interdependent set of challenges threaten human, animal, and ecosystem health, and we cannot afford to overlook important contextual factors, or the determinants of these shared threats. Health security assessment frameworks should therefore ensure that the process undertaken to prioritise and build capacity adheres to core One Health principles and that interventions and outcomes are assessed in terms of added value, trade-offs, and cobenefits across human, animal, and environmental health systems.

Summary

The apparent failure of global health security to prevent or prepare for the COVID-19 pandemic has highlighted the need for closer cooperation between human, animal (domestic and wildlife), and environmental health sectors. However, the many institutions, processes, regulatory frameworks, and legal instruments with direct and indirect roles in the global governance of One Health have led to a fragmented, global, multilateral health security architecture. We explore four challenges: first, the sectoral, professional, and institutional silos and tensions existing between human, animal, and environmental health; second, the challenge that the international legal system, state sovereignty, and existing legal instruments pose for the governance of One Health; third, the power dynamics and asymmetry in power between countries represented in multilateral institutions and their impact on priority setting; and finally, the current financing mechanisms that predominantly focus on response to crises, and the chronic underinvestment for epidemic and emergency prevention, mitigation, and preparedness activities. We illustrate the global and regional dimensions to these four challenges and how they relate to national needs and priorities through three case studies on compulsory licensing, the governance of water resources in the Lake Chad Basin, and the desert locust infestation in east Africa. Finally, we propose 12 recommendations for the global community to address these challenges. Despite its broad and holistic agenda, One Health continues to be dominated by human and domestic animal health experts. Substantial efforts should be made to address the social–ecological drivers of health emergencies including outbreaks of emerging, re-emerging, and endemic infectious diseases. These drivers include climate change, biodiversity loss, and land-use change, and therefore require effective and enforceable legislation, investment, capacity building, and integration of other sectors and professionals beyond health.

Abstract

Underrepresentation of women in scientific leadership is a global problem. To understand and counter narratives that limit gender equity in African science, we conducted a public engagement campaign. Scientists representing six sub-Saharan African countries and multiple career stages used superhero imagery to create a diverse and unified team advocating for gender equity in science. In contrast to many traditional scientific environments and global campaigns, this “PowerPack of SuperScientists” was led by early-career Black female scientists whose perspectives are often under-represented in discussions about gender equity in science. The superhero imagery served as a powerful and fun antidote to imposter syndrome and helped to subvert traditional power structures based on age, race and sex. In an interactive social media campaign, the PowerPack developed insights into three themes: a) cultural stereotypes that limit women’s scientific careers, b) the perception of a “conflict” between family and career responsibilities for women scientists, and c) solutions that can be adopted by key stakeholders to promote gender equity in African science. The PowerPack proposed solutions that could be undertaken by women working individually or collectively and interventions that require allyship from men, commitment from scientific institutions, and wider societal change. Further work is required to fully engage African scientists from even more diverse and disadvantaged backgrounds and institutions in these solutions and to enhance commitment by different stakeholders to achieving gender equity in science. Our experience suggests that creative tools should be used to subvert power dynamics and bring fresh perspectives and urgency to this topic.
