## **Syria**

### **[UN Syria Commission of Inquiry: Those responsible for atrocities during 12 years of violence must be brought to justice](#)**

*Statements* 17 March 2023

This week marks 12 years of crisis and bloodshed in Syria. The country remains deeply divided, plagued by predatory armed actors, its people shelled by their own government and bombed by a multitude of states.

The tragic earthquake struck a country suffering from years of man-made disaster, where hospitals and schools were already decimated by years of fighting. **Despite the many calls for solidarity, the immediate resumption of attacks in the earthquake zone exposes a cruelty and cynicism on the part of the parties responsible.**

The children, women and men of Syria who demonstrated for a brighter future paid the price when the Syrian Government unleashed overwhelming violence to quell dissent. Since then, armed groups proliferated, foreign states intervened, and terrorist groups became entrenched.

Throughout it, the interests of the Syrian people and basic respect for their humanity have also become casualties of this conflict. Tens of thousands remain in arbitrary and incommunicado detention or disappeared by parties deliberately withholding information on their fate and whereabouts.

**The warring parties' attempts to resolve the conflict militarily have enabled the violation or abuse of nearly every core human right. Parties to the conflict have cumulatively committed almost every crime against humanity listed in the Rome Statute, and nearly every war crime applicable in a non-international armed conflict.**

It should not be a foregone conclusion that the violations, abuses, and crimes continue into the 13th year. The interest of the Syrian people must finally be put first and every effort expended to move toward a peaceful, negotiated resolution to the conflict and finally put Syria on a path toward a stable, prosperous and just future for all her people.

## **International Criminal Court/ICC :: Ukraine**

### **[Statement by Prosecutor Karim A. A. Khan KC on the issuance of arrest warrants against President Vladimir Putin and Ms Maria Lvova-Belova](#)**

On 22 February 2023, I submitted applications to Pre-Trial Chamber II of the International Criminal Court for warrants of arrest in the context of the Situation in Ukraine.

**Today, the Pre-Trial Chamber has issued arrest warrants** in relation to the following two individuals:

- Mr Vladimir Putin, President of the Russian Federation; and
- Ms Maria Lvova-Belova, Commissioner for Children's Rights in the Office of the President of the Russian Federation.

**On the basis of evidence collected and analysed by my Office pursuant to its independent investigations, the Pre-Trial Chamber has confirmed that there are reasonable grounds to believe that President Putin and Ms Lvova-Belova bear criminal responsibility for the unlawful deportation and transfer of Ukrainian children from occupied areas of Ukraine to the Russian Federation**, contrary to article 8(2)(a)(vii) and article 8(2)(b)(viii) of the Rome Statute.

Incidents identified by my Office include the deportation of at least hundreds of children taken from orphanages and children's care homes. Many of these children, we allege, have since been given for adoption in the Russian Federation. **The law was changed in the Russian Federation, through Presidential decrees issued by President Putin, to expedite the conferral of Russian citizenship, making it easier for them to be adopted by Russian families.**

My Office alleges that these acts, amongst others, demonstrate an intention to permanently remove these children from their own country. **At the time of these deportations, the Ukrainian children were protected persons under the Fourth Geneva Convention.**

We also underlined in our application that most acts in this pattern of deportations were carried out in the context of the acts of aggression committed by Russian military forces against the sovereignty and territorial integrity of Ukraine which began in 2014.

In September last year, I addressed the United Nations Security Council and emphasised that the investigation of alleged illegal deportation of children from Ukraine was a priority for my Office. The human impact of these crimes was also made clear during my most recent visit to Ukraine. While there, I visited one of the care homes from which children were allegedly taken, close to the current frontlines of the conflict. The accounts of those who had cared for these children, and their fears as to what had become of them, underlined the urgent need for action.

**We must ensure that those responsible for alleged crimes are held accountable and that children are returned to their families and communities. As I stated at the time, we cannot allow children to be treated as if they are the spoils of war.**

Since taking up my position as Prosecutor, I have emphasised that the law must provide shelter to the most vulnerable on the front lines, and that we also must put the experiences of children in conflict at the centre of our work. To do this, we have sought to bring our work closer to communities, draw on advanced technological tools and, crucially, build innovative partnerships in support of our investigative work.

I am grateful for the support of many partners of the Office that have allowed us to move forward rapidly in the collection of evidence. I wish to express my thanks in particular to the Office of the Prosecutor General of Ukraine whose engagement has been essential in supporting the work my Office has carried out, including on the ground in Ukraine. Our participation in the Joint Investigation Team

with national authorities from seven States, under the auspices of Eurojust, has also facilitated swift access to relevant information and evidence.

**I will also continue to seek cooperation from the Russian Federation in relation to the Situation in Ukraine**, and ensure my Office fully meets its responsibility pursuant to article 54 of the Rome Statute to investigate incriminating and exonerating circumstances equally.

**Whilst today is a first, concrete step with respect to the Situation in Ukraine, my Office continues to develop multiple, interconnected lines of investigation.**

As I stated when in Bucha last May, Ukraine is a crime scene that encompasses a complex and broad range of alleged international crimes. We will not hesitate to submit further applications for warrants of arrest when the evidence requires us to do so.

**[Situation in Ukraine: ICC judges issue arrest warrants against Vladimir Vladimirovich Putin and Maria Alekseyevna Lvova-Belova](#)**

Today, 17 March 2023, Pre-Trial Chamber II of the International Criminal Court ("ICC" or "the Court") issued warrants of arrest for two individuals in the context of the situation in Ukraine: Mr Vladimir Vladimirovich Putin and Ms Maria Alekseyevna Lvova-Belova.

**Mr Vladimir Vladimirovich Putin, born on 7 October 1952, President of the Russian Federation, is allegedly responsible for the war crime of unlawful deportation of population (children) and that of unlawful transfer of population (children) from occupied areas of Ukraine to the Russian Federation (under articles 8(2)(a)(vii) and 8(2)(b)(viii) of the Rome Statute).** The crimes were allegedly committed in Ukrainian occupied territory at least from 24 February 2022. There are reasonable grounds to believe that Mr Putin bears individual criminal responsibility for the aforementioned crimes, (i) for having committed the acts directly, jointly with others and/or through others (article 25(3)(a) of the Rome Statute), and (ii) for his failure to exercise control properly over civilian and military subordinates who committed the acts, or allowed for their commission, and who were under his effective authority and control, pursuant to superior responsibility (article 28(b) of the Rome Statute).

**Ms Maria Alekseyevna Lvova-Belova, born on 25 October 1984, Commissioner for Children's Rights in the Office of the President of the Russian Federation, is allegedly responsible for the war crime of unlawful deportation of population (children) and that of unlawful transfer of population (children) from occupied areas of Ukraine to the Russian Federation (under articles 8(2)(a)(vii) and 8(2)(b)(viii) of the Rome Statute).** The crimes were allegedly committed in Ukrainian occupied territory at least from 24 February 2022. There are reasonable grounds to believe that Ms Lvova-Belova bears individual criminal responsibility for the aforementioned crimes, for having committed the acts directly, jointly with others and/or through others (article 25(3)(a) of the Rome Statute).

Pre-Trial Chamber II considered, based on the Prosecution's applications of 22 February 2023, that **there are reasonable grounds to believe that each suspect bears responsibility for the war crime of unlawful deportation of population and that of unlawful transfer of population from occupied areas of Ukraine to the Russian Federation, in prejudice of Ukrainian children.**

The Chamber considered that the warrants are secret in order to protect victims and witnesses and also to safeguard the investigation. Nevertheless, mindful that the conduct addressed in the present situation is allegedly ongoing, and that the public awareness of the warrants may contribute to the prevention of the further commission of crimes, the Chamber considered that it is in the interests of justice to authorise the Registry to publicly disclose the existence of the warrants, the name of the suspects, the crimes for which the warrants are issued, and the modes of liability as established by the Chamber.

The abovementioned warrants of arrests were issued pursuant to the applications submitted by the Prosecution on 22 February 2023.

## **War Crimes – Ukraine**

### **[War crimes, indiscriminate attacks on infrastructure, systematic and widespread torture show disregard for civilians, says UN Commission of Inquiry on Ukraine](#)**

GENEVA/ VIENNA (16 March 2023) – **Russian authorities have committed a wide range of violations of international human rights law and international humanitarian law in various regions of Ukraine, many of which amount to war crimes, the Independent International Commission of Inquiry on Ukraine said in a new [report](#) Thursday.**

The war crimes include attacks on civilians and energy-related infrastructure, wilful killings, unlawful confinement, torture, rape and other sexual violence, as well as unlawful transfers and deportations of children.

**The Commission’s evidence shows that in areas that came under their control, Russian authorities have committed wilful killings of civilians or persons not involved in fighting (hors de combat), which are war crimes and violations of the right to life.**

Russian armed forces have carried out attacks with explosive weapons in populated areas with an apparent disregard for civilian harm and suffering, failing to take the required precautions. The attacks were indiscriminate and disproportionate, in violation of international humanitarian law. The use of explosive weapons in populated areas has been one of the main causes of civilian casualties. The Commission was struck by the extent of the destruction it has observed during its visits.

**The waves of attacks by Russian armed forces on Ukraine’s energy-related infrastructure from 10 October 2022, may amount to crimes against humanity,** according to the Commission, which said that this should be investigated further. The disruption of energy-related infrastructure led to entire regions and millions of people being left for periods without electricity or heating, particularly during freezing temperatures.

**The Commission established a pattern of widespread unlawful confinement in areas controlled by Russian armed forces, targeting broad categories of men, women and children.** Confinement in dedicated facilities across Ukraine and in the Russian Federation was accompanied by consistent methods of torture against certain categories of persons by Russian authorities. A former detainee underwent beatings as a “punishment for speaking Ukrainian” and for

“not remembering the lyrics of the anthem of the Russian Federation”. This pattern of torture may amount to crimes against humanity, according to the Commission, and should be investigated further.

**The Commission found numerous instances of rape and sexual and gender-based violence committed by Russian authorities** as they undertook house-to-house visits in localities that came under their control and during unlawful confinement. Sexual violence amounting to torture and the threat of such against women and men have been important aspects of the torture exercised by Russian authorities.

While looking into transfers of children from Ukraine to the Russian Federation, the Commission found, with concern, that violations of human rights and international humanitarian law have been committed. **Situations concerning the transfer and deportation of children which it has examined amount to war crimes.** Witnesses told the Commission that many of the younger children transferred were not able to establish contact with their families and might lose contact with them indefinitely. Delay in the repatriation of civilians may also amount to a war crime.

The Commission also documented a small number of violations committed by Ukrainian armed forces, including likely indiscriminate attacks and two incidents qualifying as war crimes, where Russian prisoners of war were shot, wounded and tortured.

Beyond sharing their deep loss and trauma with the Commission, survivors highlighted the importance of identifying those responsible and holding them accountable. One man, whose father was executed by Russian armed forces in the Iziurm region, told the Commission: “They punished innocent people; now those who are guilty, if they are still alive, need to be punished to the fullest extent.” The Commission recommends that all violations and crimes be investigated and those responsible be held accountable, either at the national or the international level. It calls for a comprehensive approach to accountability that includes both criminal responsibility and the victims’ right to truth, reparation, and non-repetition.

For the report, the Commission visited 56 localities and interviewed 348 women and 247 men. Its investigators inspected sites of destruction, graves, places of detention and torture, as well as weapon remnants, and consulted a large number of documents and reports. ## **Peace; Cybercrimes**

### **[146th IPU Assembly adopts historic outcomes on peaceful coexistence and cybercrimes](#)**

At the 146th IPU Assembly in Manama, Bahrain, parliamentarians representing close to 140 countries adopted by consensus the **Manama Declaration: *Promoting peaceful coexistence and inclusive societies: Fighting intolerance*** and a landmark resolution on ***Cybercrimes: The new risks to global security***.

#### ***The Manama Declaration: A message of hope***

The Declaration follows a debate in which a record 151 parliamentarians spoke before an audience of their peers from every corner of the world.

**In the Declaration, the parliamentarians pledge “to fight inequality through rights-based economic and social policies that put people before profit and the weak before the strong, and that uphold the equality and dignity of every person.”** The declaration also urges parliamentarians “to implement the Sustainable Development Goals by 2030 – leaving no one behind – as the best hope for peace, democracy and sustainable development for all.”

The Declaration is a message of hope which calls for a more tolerant world where diversity is celebrated, and where every human being is recognized for their contribution to society. It also **calls for parliamentarians to make “hate-motivated acts and all forms of violence linked to religion, belief, xenophobia, racism or intolerance of marginalized groups an offence under the law.”**

### ***Cybercrimes: The new risks to global security***

The IPU resolution is timely given the increase in cybercrimes worldwide due to a growing reliance on technology and the digitalization of many aspects of life, which accelerated during the COVID-19 pandemic. It also means that a forthcoming United Nations convention on cybercrime, expected in 2024, will have direct upstream input from parliaments.

**There is no comprehensive definition of cybercrimes.** According to the [United Nations Office on Drugs and Crime](#), cybercrimes are acts that violate the law and are perpetrated using information and communications technologies. Aside from attacks on computer systems, they include a wide range of other acts that can be facilitated by technology, including online child sexual exploitation and abuse.

**The resolution underlines the need for international cooperation to address cybercrimes, as well as to protect global peace, security and economic stability while upholding human rights, including freedom of speech.**

The resolution emphasizes the responsibility of parliaments in building a regulatory framework to protect citizens in cyberspace in the same way as in the physical world. It notes that cybercrimes may constitute a serious threat to democratic processes, especially interference in elections through cybersecurity breaches or false social media accounts.

It acknowledges that women, young people and children are among the most vulnerable and suffer from the most aggressions on the internet.

**The resolution is the result of a long consultative process, including a record 320 amendments received from Member Parliaments, often with opposing views, culminating in a final agreed text,** demonstrating the importance and sensitivity of the issue today.

#### **[Growing securitisation in technology risks co-operation on responses to global crises - OECD](#)**

The latest [OECD Science, Technology and Innovation Outlook 2023](#) says that recent measures by China, the European Union and the United States – which between them account for more than two-thirds of global spending on Research & Development (R&D) – to **reduce international technology**

**dependencies could lead to a weakening of science, technology and innovation activities at a time when global challenges, more than ever, require international co-operation.**

Data on collaboration based on scientific publications shows early signs of China-US disengagement from bilateral collaboration in research. US co-authorship with China has fallen markedly in recent years, possibly owing to pandemic travel restrictions and denial of visas that restricted Chinese academics from travelling overseas. Most of the decline – which started in 2020 and accelerated in 2021 – is in engineering and natural sciences fields, areas that underpin developments in breakthrough technologies and which account for the bulk of bilateral research collaboration between China and the United States.

“Strategic competition should be reconciled with tackling global problems and crises,” OECD Deputy Secretary-General Kerri-Ann Jones said, presenting the report at the European Commission in Brussels. “Leadership has inevitably involved some measure of protection of technologies from strategic competitors, but today, **research and innovation are evermore interconnected across countries via trade flows, availability of critical materials and the race for talent. It is important that OECD countries carefully target their measures while keeping channels open to ambitious research and innovation co-operation to tackle current and future global challenges.**”

**The scale of China’s R&D expenditures today suggest it is gaining critical mass to innovate at the frontier in areas ranging from Artificial Intelligence to the processing of critical minerals.**

While the United States remains the world’s largest absolute spender on R&D, China sits in second place, more than tripling its number of researchers over the past 20 years. China’s R&D intensity (defined as its R&D expenditure as a share of GDP) has grown from 1.71% in 2010 to 2.45% in 2021, above the EU at 2.15% but below the US at 3.46%. China is now a market leader in some technologies, such as 5G, and at the forefront in others, including batteries and wind turbines...

#### *Abstract*

Sociotechnical systems in areas like energy, agrifood and mobility need to transform rapidly to become more sustainable and resilient. Science, technology and innovation (STI) have essential roles in these transformations, but governments must be more ambitious and act with greater urgency in their STI policies to meet these challenges. They should design policy portfolios that enable transformative innovation and new markets to emerge, challenge existing fossil-based systems, and create windows of opportunity for low-carbon technologies to break through. This calls for larger investments but also greater directionality in research and innovation, for example, through mission-oriented policies, to help direct and compress the innovation cycle for low-carbon technologies. International co-operation will be essential, but rising geopolitical tensions, including strategic competition in key emerging technologies, could make this difficult. OECD Science, Technology and Innovation Outlook 2023 explores these and other key issues and trends that present STI with a new operating environment to which it must adapt.

## Emerging technology governance: Towards an anticipatory framework

### Policy framework for emerging technology governance




Emerging technologies have the potential to drive much-needed transformations and responses to crises, but they also pose risks and challenges. In this context, technology governance has evolved to address the high uncertainty, risk, and complexity associated with emerging technologies. While there is no one-size-fits-all approach, a general and anticipatory framework for governing emerging technologies could be useful at the national or international level. It could help anticipate concerns, address them through open and inclusive processes, and align innovation trajectories with societal goals.

The OECD is developing an anticipatory policy framework to embed values more purposefully into the technology development process. This could help shift the focus of governance from exclusively managing the risks of technologies to engaging stakeholders in the innovation process early on. Using upstream design principles and tools can help balance the need to drive the development and scale-up of technologies with helping to realise just transitions and values-based technology.

## Mobilising science in times of crisis: Lessons learned from COVID-19

### Policy for science & science for policy



The COVID-19 crisis demonstrated the importance of science in developing solutions for global challenges. To prepare for future crises such as climate change or pandemics, collaboration between scientists, policymakers, and the public is key to success, but this requires changes to academic culture and incentives. Many of the required changes – including in research performance assessment, public engagement, and transdisciplinary research – are already underway but have not yet been adopted at the necessary scale and speed because of inertia in science systems. More radical change is necessary to spur science to engage with other societal stakeholders to produce the broader range of outputs and solutions that are urgently required to deal with complex global challenges and crises.

### **[Humanitarian action is the answer to fewer and fewer of today's humanitarian crises](#)**

As the scale and scope of humanitarian crises are expanding, the suitability of humanitarian action as the right kind of response to them is declining. At the beginning of this year the United Nations (UN) appealed for a record \$51.5 billion to meet the needs of 339 million people – a figure that has already proved to be an underestimate with the Turkish earthquake response. Global humanitarian funding requirements are rising inexorably and are likely to surpass \$100 billion by 2027.

Added to the scale is the widening scope of crises. Armed conflict remains the main driver of humanitarian needs. As we are increasingly reminded, the climate crisis is a humanitarian crisis. The Covid-19 pandemic put health emergencies centre stage for humanitarian actors for a while. And political instability and economic collapse are also now seen as causing humanitarian problems, as events in Sri Lanka and Lebanon have shown.

However, just because humanitarian crises are growing in scale and scope it does not mean that international humanitarian assistance is necessarily the right kind of help needed for affected countries. The traditional model of humanitarian response is large international agencies scaling up the sectoral assistance they provide directly to affected populations; this is increasingly ill-suited to many of today's crises.

It is not just a case of the humanitarian system being broken, but rather that international humanitarian assistance might not necessarily be the best way of responding to these situations. It is perhaps time to accept this...

Humanitarian aid and development cooperation are becoming far more difficult to distinguish, at least in terms of the problems they respond to. It is not inconceivable that the World Bank will become one of the most important funders for humanitarian actors in the future.

The humanitarian system has always only ever been one source of support for people in crisis, varying significantly from one context to the next. By recent estimates humanitarian aid accounted for 46% of aid flows to Yemen in 2019, compared to just 1% in Bangladesh.

The realities presented above are not new, but they are becoming more pronounced. Paradoxically, at a time when humanitarian needs are at their highest level, the suitability of humanitarian assistance to address them appears to be declining. It is perhaps no coincidence that the humanitarian funding gap

has grown in recent years, with appeals receiving only 53% of requirements in 2021 compared to 64% in 2019. Where international humanitarian assistance is most necessary needs rethinking in order to remain effective...

There is no doubt that the humanitarian system has been slow to adapt to remain effective in today's crises. It clearly needs to embark on more deep-seated reforms to maintain its relevance. The current system-wide review of the humanitarian response to internal displacement provides the opportunity for a more fundamental assessment of what is not working. The starting point should be that there are no standardised approaches to the multitude of different humanitarian crises occurring today, and the humanitarian system needs to be more adaptable.

If other actors are playing a more critical role in crisis response, humanitarian actors also need to enhance their collaboration with them. The humanitarian–development–peace nexus approach requires far more radical changes to the aid system, if it is to be successfully implemented. These changes include: inter-agency humanitarian and development plans being combined to provide a holistic approach to crisis response; donors consolidating their humanitarian and development funding streams; and the UN's humanitarian and development coordination offices becoming more aligned.

The humanitarian landscape is constantly evolving, but the assumption that this requires more international humanitarian assistance should be questioned. While counter-intuitive, the blurring scope of humanitarian action needs more attention. Humanitarian actors need to acknowledge that they might not necessarily have the answer – this is the first step to increasing their own relevance in such circumstances...



### **Weekly epidemiological update on COVID-19 - 16 March 2023**

*Overview*

Globally, nearly 4.1 million new cases and 28 000 deaths were reported in the last 28 days (13 February to 12 March 2023), a decrease of 40% and 57%, respectively, compared to the previous 28 days; however, there are significant regional differences including increases in some regions. **Türkiye**

- So far, flash flooding has claimed 18 lives in the cities of Adiyaman and Sanliurfa, according to the Government. The floodwaters inundated camps housing people displaced by last month's earthquakes. Authorities say some 220,000 people are living in tents in and around Adiyaman.
- As of yesterday, some 2.3 million people are sheltering in temporary settlements – with 1.6 million of them in informal sites. Many camps lack access to clean water, sanitation and hygiene facilities, and overcrowding is a major concern.
- Access to education is also a problem for nearly 4 million children, of whom 350,000 are refugees and migrants. We and our partners have set up 87 temporary learning sites for more than 6,000 children in Gaziantep, Hatay and Kahramanmaras.

- UN agencies and our partners have reached more than 520,000 people with water, sanitation, and hygiene assistance. About 45,000 people have received health and nutrition assistance. The World Food Programme has provided more than 6 million food packages and hot meals.
- Meanwhile, UN Disaster Assessment and Coordination teams continue to work with Turkish authorities on humanitarian relief efforts in Adiyaman, Hatay, Kahramanmaras, and Malatya.
- Funding is urgently needed to help more than 5 million people affected by the earthquakes. The [flash appeal](#) for \$1 billion is just over 16 percent funded.

### **Syria**

OCHA and its partners continue to scale up their efforts to help millions of people affected by the earthquakes.

- The [flash appeal](#) for \$400 million is now 72 percent funded.
- In northwest Syria, more than 103,000 people have been internally displaced since 6 February.
- As of today, nearly 900 trucks carrying aid from seven UN agencies have crossed into the northwest from southern Türkiye, through the three available border crossings.
- In the past 10 days, more than 1.3 million people in northwest Syria have been vaccinated against cholera. That response is being led by WHO and UNICEF.
- Nearly 200,000 people in Idlib and Aleppo received multi-purpose cash assistance last month, totaling \$6.4 million,,,

*Situation at a glance*

On 2 January 2023, an outbreak of measles was confirmed in Nepalgunj sub-metropolitan city (SMC) in Banke district, Nepal, following a cluster of cases of fever and rash. Following the confirmation and through active case search, the index case was identified, with the onset of symptoms on 24 November 2022. Between 24 November 2022 and 10 March 2023, 690 measles cases, including one associated death (case fatality ratio: 0.14 %), have been reported from seven districts in western Nepal, and three districts in eastern Nepal (mainly in the Terai ecological region). The majority of the cases (n=591; 86%) have been reported in children aged less than 15 years.

While measles is endemic in Nepal and is reported every year, the magnitude and extent of the current outbreak are unusually high compared to the previous years...

GENEVA – The Global Fund to Fight AIDS, Tuberculosis and Malaria and Unitaid welcome WHO's recommendation for the widespread use of a new class of mosquito net that uses two active ingredients – pyrethroid and chlorfenapyr. The new net has demonstrated approximately double the protection against malaria provided by the standard pyrethroid-only nets in areas where mosquitoes have already developed resistance to pyrethroids.

Randomized controlled trials in Tanzania and Benin over a two-year period demonstrated that the dual active ingredient insecticide-treated nets reduced malaria infections by approximately 50% among children between the ages of 6 months and 10 years.

Children and pregnant women are particularly vulnerable to malaria. According to the 2022 World Malaria Report, almost 80% of malaria deaths occur in children under 5. Most of the remaining deaths occur in children under 10 and pregnant women, especially in sub-Saharan Africa.

"This shows how we can accelerate impact by embracing innovation," said Peter Sands, Executive Director of the Global Fund. "The issuance of guidance by WHO is critical to influencing broad uptake of the new nets and to combat growing insecticide resistance across Africa, where nearly all malaria infections and related deaths occur."...

#### **Human genome editing: ensuring responsible research**

The Lancet

In 2018, during the Second International Summit on Human Genome Editing in Hong Kong, Jiankui He shocked the world by announcing the birth of two children whose genomes he had edited using CRISPR technology. Following widespread condemnation and a criminal investigation, he was sentenced to 3 years in prison. The case caused international outcry and brought to the fore the need to reconsider the serious ethical, scientific, and social issues of heritable human genome editing. As science advances, especially in non-heritable, somatic gene editing for treatment of previously incurable diseases, regulatory gaps are becoming exposed. Governance of gene editing research was a major discussion point at the Third International Human Genome Editing Summit in London, on March 6–8, with widespread recognition for the need to build on existing guidelines to develop global standards for governance and oversight of human genome editing. As He's unconscionable actions showed, the ethical and scientific risks are substantial.

Gene editing regulations must consider the aims and consequences of the different practices involved. Somatic genome editing interventions (eg, targeted therapies such as chimeric antigen receptor T cells or small interfering RNA gene therapies) are not transmitted to offspring and are widely used. Heritable genome editing—also called germline editing—is aimed at research on human fertilisation and embryology or for reproductive purposes. From a genetic point of view, germline editing is of most concern because alterations are passed to offspring, with the risk of perpetuating unexpected and undesired changes through generations. It is impossible for our unborn descendants to give consent.

Loopholes and ambiguities in regulation need to be closed urgently to enable scientists to be held to account. In China, He's prosecution was based on practising medicine without a licence, rather than specifically based on a provision governing assisted reproduction or genome editing. China has since instituted new regulations, widely seen as a response to the He case, but they have been criticised in press reports for not doing enough to cover private companies. Wording of legislation needs to be explicit and clear. In the USA, use of funds by the FDA for the purpose of accepting and reviewing any application to begin a clinical trial for heritable germline editing is prohibited. While this, in effect,

makes some reproductive editing illegal, it falls short of a ban on the practice itself. Similar ambiguities exist in many countries, and as the technologies involved become cheaper and more widely available, the risk increases.

A better international consensus is essential on how to advance gene editing while safeguarding humanity's collective gene pool. There is broad agreement that altering embryo DNA for reproductive purposes should remain forbidden; a 2020 study showed that 75 of 96 surveyed countries have banned it. However, many do not have effective oversight and governance mechanisms to enforce existing regulations. In some countries, although altering embryo DNA is generally forbidden, exceptions are allowed, making more likely the possibility that the technology is used for a banned purpose. The lack of policy alignment between countries raises the possibility of scientists exporting their research to evade constraints established in their home jurisdictions.

How will a global consensus be enforced? The UN is the only body in a position to do so, and the prospect of an international legally binding treaty to govern genome editing was raised at the Second International Summit in 2018, but has seemingly proceeded no further. The Oviedo Convention, a legally binding instrument established by the European Council, permits somatic genome modifications for preventive, diagnostic, or therapeutic purposes, and prohibits germline editing, but only 29 countries have enacted it into law.

It is almost 20 years since scientists announced the mapping of the human genome. Now they are editing it, and the promise of a truly personalised medicine, tailored to an individual's genetic makeup, is becoming reality. The first CRISPR-based technology, for sickle cell disease, is expected to soon be approved by US regulators. Such advances have the potential to bring enormous benefits for humankind, but also bring unique social and ethical challenges. Resolving these challenges will involve ongoing conversations within and outside the scientific community. To protect legitimate genetic research—to close loopholes in regulations and establish a global consensus on oversight and regulation—will require governance that is as dynamic as the science.

##### **[Confronting the evolution and expansion of anti-vaccine activism in the USA in the COVID-19 era](#)**

#### *Introduction*

Over the past two decades, anti-vaccine activism in the USA has evolved from a fringe subculture into an increasingly well organised, networked movement with important repercussions for public health. The COVID-19 pandemic has exacerbated this evolution and magnified the reach of vaccine misinformation. Anti-vaccine activists, who for many years spoke primarily to niche communities hesitant about childhood vaccinations, have used traditional and social media to amplify vaccine-related mistruths about COVID-19 vaccines while also targeting historically marginalised racial and ethnic communities. These efforts contributed to COVID-19 vaccine hesitancy and expanded the movement, with early indications suggesting that this hesitancy could now also be increasing hesitancy that existed

pre-pandemic towards other vaccines. It is important to understand the implications of this recent evolution of anti-vaccine activism on vaccination uptake and the promotion of sound public health strategies. In this Viewpoint, we summarise the latest developments in US-based anti-vaccine activism and propose strategies for confronting them.

### **[When Refugee Presence Increases Incumbent Support through Development](#)**

*Abstract*

Studies of higher-income democracies find that the growing presence of refugees has generally been met with electoral backlash, with voters punishing incumbents and increasing support for far-right parties. Yet there is a dearth of studies on the political consequences of refugee-hosting in low-income countries, where the vast majority of refugees reside. Theoretically, we discuss why findings from high-income countries may not generalize, and we offer an alternative framework rooted in the context of low-income countries. We then test our framework empirically in Uganda, one of the largest and more inclusive refugee-hosting countries. Combining information on refugee settlements with four waves of national elections data, we find that an increase in refugee presence leads to a significant increase in incumbent support. National survey data coupled with panel data on healthcare, schools, roads, and nighttime lights suggest that the mechanism is positive externalities of inclusive refugee-hosting and aid on local public goods.

### *Abstract*

Background: This is a standardized, pre-positioned protocol for the coordinated evaluation of Lassa fever therapeutics. The protocol is the product of discussions that took place in 2021 and 2022 among international investigators from a wide range of scientific and medical disciplines working together within the West Africa Lassa fever Consortium (WALC).

Methods: This is a clinical Phase II/III multicentre randomised controlled platform trial using a superiority framework with an equal allocation ratio and a composite primary endpoint of all-cause mortality OR new onset of i) acute kidney failure (AKF), OR ii) acute respiratory failure (ARF), OR iii) shock assessed from enrolment (D0) to D28.

Discussion: This pre-positioned protocol was developed by the WALC and made available for adaptation and implementation by the wider Lassa fever research community in order to generate efficient, reliable, and comparable evidence for Lassa fever therapeutics.

### *Abstract*

The region of the Americas has been the epicenter of the COVID-19 pandemic's worst outcome in terms of number of deaths due to COVID-19. SARS-CoV-2 infection during pregnancy and the postpartum period has been found to be associated with increased risk of mortality and severe disease. Several Latin American and Caribbean countries have disproportionately high maternal mortality rates due to COVID-19. Although this region achieved relatively high vaccination rates among the general adult population, there were differing restrictions regarding the vaccination of those who were pregnant. In a pandemic, policies reflect political priorities in responses to the threats posed to populations and play an important role in promoting gender equity. This paper reports the results of an ethical analysis of 45 national COVID-19 vaccination public policies from seven countries – Argentina, Brazil, Canada, Colombia, Mexico, Peru, and United States. The analysis drew on reproductive justice and feminist bioethics frameworks, paying close attention to whether and how gender and social and economic inequities were addressed. It found that exclusionary approaches in immunization policies which restricted access to vaccination during pregnancy were often justified on the basis of a lack of evidence about the effects of immunization of pregnant persons, and on the grounds of medical expertise, to the detriment of women's autonomy and agency. As such these policies reiterate patriarchal moral understandings of women, pregnancy and motherhood. In practice, they counter human rights gender equity and equality principles, and became lethal, particularly to racialized women in Latin America. During an emerging lethal disease, policies and policy development must consider the intersection of oppressive structures to protect and guarantee rights of women, girls, and pregnant persons.

### *Abstract*

Background: Use of adaptive clinical trials, particularly adaptive platform trials, has grown exponentially in response to the coronavirus disease (COVID-19) pandemic. Implementation of these trials in low- and middle-income countries (LMICs) has been fostered through the formation or modification of transnational research partnerships, typically between research groups from LMICs and high-income countries (HICs). While these partnerships are important to promote collaboration and overcome the structural and economic disadvantages faced by LMIC health researchers, it is critical to focus attention

on the multiple dimensions of partnership equity.

Methods: Based on informal literature reviews and meetings with leaders of one of the multinational COVID-19 adaptive platform trials, we describe what can be learned about research partnership equity from these experiences.

Results: We organize these considerations into eight thematic categories: 1) epistemic structures, 2) funding, 3) ethics oversight, 4) regulatory oversight, 5) leadership, 6) post-trial access to interventions, data, and specimens, 7) knowledge translation, and 8) research capacity strengthening and maintenance. Within each category we review the normative claims that support its relevance to research partnership equity followed by discussion of how adaptive platform trials highlight new dimensions, considerations, or challenges.

Conclusion: These observations provide insight into procedural and substantive equity-building measures within transnational global health research partnerships more broadly.
