#### **Child Rights, Benefits, Protection**

**1.4 billion children globally missing out on basic social protection, according to latest data** *Fewer than one in ten children in low-income countries have access to child benefits, leaving them vulnerable to disease, missed education, poor nutrition, poverty and inequality* 

NEW YORK, 14 February 2024 – Globally, **1.4 billion children aged 0-15 lack any form of social protection, leaving them vulnerable to disease, poor nutrition and poverty**, according to new data released today by the **International Labour Organization (ILO)**, **Save the Children and UNICEF.** 

In low-income countries, less than one in ten children in this age group have access to child benefits, highlighting a significant disparity compared to the coverage enjoyed by children in high-income countries.

**Child benefits are a critical form of social protection**, intended to promote the long-term wellbeing of children. Paid in cash or tax credits, child benefits are essential for reducing poverty, as well as accessing healthcare, nutrition, quality education and water and sanitation. Additionally, these benefits support socio-economic development, particularly in times of crisis.

In such contexts, many children are deprived of the basic resources and services they need to escape poverty, and are therefore exposed to the long-lasting impacts of hunger, malnutrition, and unrealised potential. The three organisations are calling on governments to ensure all children are shielded by social protection mechanisms, including through universal child benefits.

The data shows there has been a modest global increase in access to child benefits over a period of 14 years, from 20 per cent in 2009 to 28.1 per cent in 2023. However, the **progress has been unequal**. **In low-income countries, rates of coverage remain staggeringly low, at around 9 per cent**. **At the same time, 84.6 per cent of children in high-income countries are covered**...

The three agencies urge policymakers and donors to take decisive steps to attain universal social protection for all children, by:

- Building social protection systems that are rights-based, gender-responsive, inclusive, and shock-responsive to address inequities and deliver better results for girls and women, children with disabilities, migrant children, and children in child labour for example.
- Closing protection gaps require filling the 'financing gap'. This means investing in child benefits for all children offers a proven and cost-effective way to combat child poverty and ensure children thrive.
- Providing a comprehensive range of child benefits through national social protection systems that also connect families to crucial health and social services, such as free or affordable highquality childcare.

- **Securing sustainable financing** for social protection systems by mobilising domestic resources and increasing public investment in children.
- Strengthening social protection for parents and caregivers by guaranteeing access to decent work and adequate benefits, including unemployment, sickness, maternity, disability, and pensions.

# Education

#### UNESCO Member States adopt global framework to strengthen Culture and Arts education 15 February 2024 PDF:<u>https://www.unesco.org/sites/default/files/medias/fichiers/2024/02/WCCAE\_UNESCO%20Framew</u> ork\_EN\_0.pdf

Today, UNESCO Member States unanimously adopted a new global *Framework for Culture and Arts Education.* Among the commitments made: to give **greater priority to culture and arts education in teacher training, to put more emphasis on local and indigenous cultures and heritage** in the classroom, and to better recognize artistic and cultural skills within the professional world. To translate this Framework into action, UNESCO and the United Arab Emirates also announced a new major initiative.

The World Conference on Culture and Arts Education, organized by UNESCO and United Arab Emirates in Abu Dhabi (13-15 February), brought together nearly 1,000 culture and education stakeholders – including 90 ministers, 125 representatives of UNESCO Member States, policy-makers, experts and NGOs, as well as UN agencies, academia and the private sector.

The new UNESCO Framework stresses the need for lifelong learning in culture and art within all types of educational settings, and for placing culture and the arts at the heart of education policies, strategies, curricula, and programmes. **The Framework broadens the understanding of "culture" to encompass built, natural and living heritage, cultural expressions, as well as the cultural and creative industries.** It also focuses on the capacities of digital technologies in culture and arts education to help promote intercultural dialogue and linguistic diversity.

The text adopted also recognizes that learning in, through and with cultural diversity is vital for overcoming divisions and fostering mutual understanding. It underlines the need for greater emphasis on local – and especially indigenous – cultures and heritage...

# I. Guiding principles

...

# 7. Culture and arts education should be holistic, transformative, and impactful, and guided by the following principles:

a. Ensure culture and arts education as a common good of humanity that should be accessible to all, and which foster well-being of individuals and societies as a whole. This recognition further requires strengthening its role within policy, education systems and societies at large, as well as enhancing collective engagement and sustained public investment.

- b. Guarantee that culture and arts education is grounded in human rights and fundamental freedoms, as defined by international human rights instruments, primarily the United Nations Charter, the Universal Declaration of Human Rights, the International Covenants on Economic, Social and Cultural Rights, and on Civil and Political Rights, and other international conventions and treaties on human rights, which are enabling conditions for the inclusive and sustainable development of individuals, communities and societies.
- c. Mainstream gender equality in all aspects of policy planning, design and implementation, as well as counter gender discrimination and bias, harmful content and violence in all educational settings, as well as experiences and practices related to culture and arts education.
- d. **Recognize cultural diversity as a defining feature and common heritage of humanity** that expands the choices, capacities and nurtures the values of individuals and societies, and which should be protected and promoted through fostering mutual understanding, equitable access to diverse cultural expressions, and linguistic diversity in all physical, virtual and blended educational settings....

# **IV. Strategic Goals**

a. Access, inclusion, and equity in and through culture and arts education

...15. Education must be democratized, foster critical views and support the struggle against colonialism and neo-colonialism in all their forms and manifestations, and be free from stereotypes, bias and prejudice, based on the respect for the diversity of learners, and entails countering hierarchy between cultures, cultural practices, arts disciplines or expressions towards more inclusive and pluralist societies. All learners, especially Indigenous Peoples, persons with disabilities, those in disadvantaged, impoverished and vulnerable situations, such as refugees, migrants, displaced persons, victims of armed conflict, and learners in crisis-affected and post-disaster contexts, should be able to access, participate in and contribute to relevant culture and arts education and thrive as a result.

16. Education must, therefore, provide diverse, inclusive and flexible, inter-, multi- and transdisciplinary approaches and methods to deliver culture and arts education of quality that contributes to **addressing stigma, xenophobia, hate speech, disinformation, misinformation and discrimination**. This includes enhancing the knowledge and the appreciation of cultural diversity, human rights, intercultural understanding and respect, social cohesion, conflict prevention, and post-conflict reconciliation and healing through culture and the arts...

#### c) Appreciation of cultural diversity and the capacity for critical engagement

...19. Culture, in its rich diversity, should be integrated in and across formal, non-formal and informal education, enabling the inclusion of a plurality of identities and cultural expressions of peoples and societies making up humanity, and promoting knowledge and awareness through self-expression, discovery and experimentation. **Culture is dynamic, heterogeneous and constantly evolving, and provides a critical space for interaction, exchange, contestation, co-learning, and creation, and thereby contributes to the vitality and diversity of societies.** 

20. Educational approaches, pedagogies and tools should equip learners with the essential knowledge, skills, values, attitudes and agency to **use art for promoting social change**, to safeguard cultural assets through place-based approaches and strategies, and to identify and challenge forms of instrumentalization of culture, and harmful social norms, bias and stereotypes, **while fostering the positive appreciation of cultural diversity as a constructive force to enable freedom of expression and freedom of creation, active democratic participation, social responsibility, creativity and innovation, and cohesion and collaboration...**

#### **Environmental Crimes**

The Office of the Prosecutor launches public consultation on a new policy initiative to advance accountability for environmental crimes under the Rome Statute

International Criminal Court (ICC) *Statement* 16 February 2024

The Prosecutor of the International Criminal Court, Mr Karim A.A. Khan KC, is pleased to announce a new policy initiative to advance accountability for environmental crimes under the Rome Statute. The Office of the Prosecutor is commencing today **a process that will culminate in a comprehensive policy paper on Environmental Crimes, aiming to ensure that it takes a systematic approach to dealing with crimes within the Court's jurisdiction committed by means of, or that result in, environmental damage.** 

This new policy initiative will help promote accountability, transparency, and predictability in the Office's work in this crucial area. The policy paper on environmental crimes will be developed on the basis of the **Rome Statute and other regulatory instruments of the Court, as well as on applicable environmental treaties, rules of customary international law, and the jurisprudence of other international and national courts.** 

Through this announcement, **the Prosecutor invites comments early in the development of this policy initiative, calling for input on, inter alia, what specific crimes within the Court's jurisdiction should be included in the policy paper; how** to understand and apply the applicable modes of participation in those crimes; best practices for investigating and prosecuting crimes that can be committed by means of or that result in environmental damage; and how to consider environmental crimes when putting into practice the principle of complementarity and engaging in international cooperation...

# In this first round of external consultations, the Office welcomes and encourages comments on the substance of the policy paper prior to the first draft being produced.

Following the development of a draft policy paper on the basis of this initial input, there will be a second round of public consultations on the draft itself. As part of that second major consultation phase, the Office will also host a number of roundtable discussions to address key pillars of the emerging policy with relevant counterparts from civil society, national authorities, affected communities and the private sector. International Court of Justice [ICJ]

Legal Consequences arising from the Policies and Practices of Israel in the Occupied Palestinian Territory, including East Jerusalem (Request for Advisory Opinion) Public hearings to be held from Monday 19 to Monday 26 February 2024 No. 2024/15

THE HAGUE, 9 February 2024. The International Court of Justice will hold public hearings on the request for an advisory opinion in respect of the Legal Consequences arising from the Policies and Practices of Israel in the Occupied Palestinian Territory, including East Jerusalem, from **Monday 19 to Monday 26 February 2024** at the Peace Palace in The Hague, the seat of the Court. **Fifty-two States and three international organizations have expressed their intention to participate in the oral proceedings before the Court.**

# <u>Gaza Strip (South Africa v. Israel) - Decision of the Court on South Africa's request for</u> <u>additional provisional measures</u>

International Court of Justice No. 2024/16

THE HAGUE, 16 February 2024. In the case concerning Application of the Convention on the Prevention and Punishment of the Crime of Genocide in the Gaza Strip (South Africa v. Israel), the Court, having duly considered <u>South Africa's letter</u> dated 12 February 2024 and <u>Israel's observations</u> thereon received on 15 February 2024, took the following decision, which was communicated to the Parties today by a letter from the Registrar:

"The Court notes that the most recent developments in the Gaza Strip, and in Rafah in particular, 'would exponentially increase what is already a humanitarian nightmare with untold regional consequences', as stated by the United Nations Secretary-General (Remarks to the General Assembly on priorities for 2024 (7 Feb. 2024)).

This perilous situation demands immediate and effective implementation of the provisional measures indicated by the Court in its Order of 26 January 2024, which are applicable throughout the Gaza Strip, including in Rafah, and does not demand the indication of additional provisional measures.

The Court emphasizes that **the State of Israel remains bound to fully comply with its obligations** under the Genocide Convention and with the said Order, including by ensuring the safety and security of the Palestinians in the Gaza Strip."

# Gaza: When mothers have to bury at least 7,700 children, very basic principles are challenged, UN women's rights committee says

GENEVA (16 February 2024) - The very principles of the <u>Convention</u> protecting women and girls are challenged when **mothers in the Gaza Strip have been put in a situation of burying at least 7,729 children in the past four months, and 5,500 women don't know if they will be able to deliver their children safely within next month,** the <u>UN Committee on the Elimination of</u> <u>Discrimination against Women</u> (CEDAW) warned today.

Calling for a peaceful and lasting resolution to the war, the Committee issued the following statement:

"On this 125th day of the war in Gaza, the Committee on the Elimination of Discrimination against Women (the Committee) appeals for an immediate and sustained ceasefire to halt violence and loss of lives, and destruction of infrastructure and property and a return to a constructive peace dialogue to agree on actions to bring about lasting peace and security that involves the leadership and decision-making of both Israeli and Palestinian women.

The Committee deplores the high toll of victims and calls upon all parties to the conflict to abide by the rule of law, international humanitarian law and international human rights law and reaffirm their commitment to the Convention on the Elimination of All Forms of Discrimination against Women (the Convention) and its preamble, **General Recommendation No. 30 (2013) on women in conflict prevention, conflict and post-conflict situations of the Committee, as well as Security Council resolution 1325 and subsequent resolutions on women, peace and security.** 

The Committee is deeply concerned about the plight of the more than one million Palestinian women and girls who have been forcibly displaced multiple times. As of 12 February 2024, UN Women reports that at least 28,340 Palestinians were killed in Gaza, and 70 per cent of those killed are said to be women and children. 67,984 Palestinians have been injured. The Convention's very principles are challenged when mothers are put in a situation of burying at least 7,729 children. As stated by UNFPA, an estimated 5,500 women are due to give birth within the next month, more than 180 delivering every day, and an estimated 840 women may experience pregnancy- or birth-related complications. The Committee condemns the inexorable march of death, disease, and destruction in the Gaza Strip.

The Committee calls on Israel to comply with the order of provisional measures of the International Court of Justice to "take all measures within its power to prevent the commission of all acts" of violence, "prevent and punish the direct and public incitement to commit genocide", and "to enable the provision of urgently needed basic services and humanitarian assistance".

The Committee calls upon Israel to allow the provision of medical personnel, medicines, water, food, fuel, shelter, and clothes to all civilians and provide a special focus on women's and girls' special needs, such as sexual and reproductive health services and sanitary and hygiene products. The clock is ticking fast towards famine and an outbreak of epidemics. The lives and health, physical and mental, of the women and girls of Gaza are severely compromised.

The Committee deplores that women are among the first victims of conflict-related violence and stresses that they are leading forces for peace. It reaffirms its profound commitment to women's leadership and decision-making at this moment of conflict and in all evolving processes in peace-building. The Committee strongly calls for reforms in the security architecture of all parties to guarantee parity with a starting minimum quota of 30 per cent for women's representation at decision-making levels around the negotiation table and in the entire peace-building continuum. Women must stop paying for the cost of war.

The Committee recognizes that the continuing war and siege cause grievous harm to all women and girls, including pregnant women and women with disabilities. This constitutes a major humanitarian, human rights and public health crisis and a stain on our collective conscience.

The Committee calls for the immediate and unconditional release of the Israeli hostages held captive by Hamas. It also calls for the immediate and unconditional release of Palestinians, including women and girls, who are arbitrarily arrested and detained by Israeli forces. The Committee warns against any pending and potential military offenses and incursions into the already limited land space of Rafah where hundreds of thousands of forcibly displaced persons, predominantly women and children, are seeking refuge.

**The Committee appeals to the Security Council** to claim an immediate and total cessation of the war in Gaza to ensure lasting peace and security in the region."

#### Background

The <u>Committee on the Elimination of Discrimination against Women</u> monitors States parties' compliance with the <u>Convention on the Elimination of All Forms of Discrimination against Women</u>, which to date has <u>189</u> States parties. The Committee is made up of <u>23 members</u> who are independent human rights experts from around the world elected by the States parties, who serve in their personal capacity and not as representatives of States parties.

#### Joint statement on conflict-induced hunger in Gaza

#### February 14, 2024

We, the signatories of this statement, call for an immediate and permanent ceasefire and a massive increase in humanitarian assistance to avoid famine in Gaza, and as the only way to comply with the United Nations Security Council Resolution 2417. Allowing access for humanitarian aid to reach the civilian population is an obligation under International Humanitarian Law and immediate measures need to be taken to effectively address and comply with the demands of the United Nations Security Council Resolution 2417 which condemns the use of starvation of civilians as a method of warfare.

The <u>risk</u> of famine is increasing each day in Gaza due to the continuation of hostilities, and the continued blockade of the Strip. The Integrated Food Security and Nutrition Phase Classification (IPC) analysis <u>results from the end of 2023 found the entire population are living with crisis-level hunger</u>, and one in four households — more than half a million people — face catastrophic conditions. **This is the highest proportion of any population in food security crisis and above on the IPC's global records.** Virtually all households are skipping meals each day. Some families go days and nights without eating. Before October 7th, acute malnutrition in Gaza was almost non-existent. However, the UN predicts that child wasting is likely to increase by <u>27 per cent</u> in Gaza in the coming months.

<u>The UN</u>, <u>Human Rights Watch</u>, and <u>humanitarian organisations</u> have warned that starvation of civilians as a method of warfare is being used in Gaza. Starvation of the civilian population is illegal under International Humanitarian Law, and in direct breach of UNSC Resolution 2417.

**Before the current conflict, humanitarian food assistance was supporting over two-thirds of the population.** Now, needs have largely increased and worsened and humanitarian assistance has reduced due to violence, insecurity and access barriers. The siege tactics imposed by Israel on Gaza are one of the key factors impeding the delivery of aid. Under International Humanitarian Law, parties to the conflict are obliged to facilitate rapid unfettered access to aid. Additional factors include the ongoing bombardments of densely populated areas, <u>including distribution sites</u>, and Israel's denial of humanitarian aid missions to the <u>North and other areas of Gaza</u>.

Infants, young children, and pregnant and lactating women are currently more vulnerable than before the conflict escalation. The wholly insufficient access to food, water and essential lifesaving services

exposes these groups to greater chances of suffering from malnutrition and disease, heightening the risk of mortality and morbidity.

Lack of adequate water and sanitation is leading to widespread diarrhoea and disease, one of the direct causes of malnutrition, along with dietary intake. Only one out of the three water pipelines coming from Israel is operational, and there is no access to clean water in the northern governorates. At least <u>twenty</u> water facilities, including reservoirs, have been damaged or destroyed. Fuel shortages are also severely impacting water infrastructure. Accumulation of solid waste in streets – approximately 50,000 tonnes – is a priority health concern.

The destruction of food production and distribution infrastructure and the restriction of commercial imports have reduced access to food. OCHA <u>reports</u> that only 15 of the 97 bakeries operating in Gaza before October 7 are still operational. Satellite imagery shows the destruction of many fishing ports, markets, greenhouses and agricultural land.

The prevention of sufficient food aid from reaching the population and targeting food production and distribution infrastructure, including farms, water systems, mills, food processing and storing sites, hubs, and means for food transportation are a direct violation of <u>United Nations Security Council</u> <u>Resolution 2417</u>. This resolution was unanimously approved in 2018 to condemn the use of hunger and starvation as a weapon of war.

Recent provisional measures delivered by the International Court of Justice demand that Israel must take immediate and effective measures to enable the provision of urgently needed basic services and humanitarian assistance in Gaza, such as food assistance and safe drinking water. Third States have the legal obligation to ensure that all parties are allowing for sufficient aid to enter Gaza, and removing any barriers to timely and unimpeded access.

.The only way to avoid the risk of famine is to immediately stop the deterioration of health, nutrition and food security, and increasing morbidity, through the **restoration of health services**, water and **sanitation services**, fisheries and agricultural lands, and markets. Avoiding famine cannot be done with ongoing hostilities. An immediate and permanent ceasefire and the scale-up of access to aid across the Gaza Strip are essential.

#### Science

#### President of the International Science Council, Sir Peter Gluckman, addresses EU Ministers

Brussels, Belgium | 15 February 2024

Sir Peter Gluckman, President of the International Science Council, addressed European Union Ministers attending the Gala Dinner for the "<u>Multilateral dialogue on principles and values for international</u> <u>cooperation in research and innovation</u>". The dialogue, held in Brussels, Belgium on 15 and 16 February promotes the EU's <u>Global Approach to Research and Innovation</u> launched in 2021. The speech addressed issues such as the challenges for science production and trust in science, decolonizing science, and evolving science for the 21st century.

...I spoke of the critical importance of distinguishing between science and science systems; something that is even more important as debates over decolonization and political attempts at undermining trust in science grow. If we want to promote international science cooperation this distinction must be understood and respected.

**Science is arguably the only universal language and is defined by a set of principles**. Given that modern science is a global activity critical to virtually every challenge we must confront, it is important that we have broadly and globally accepted understandings of how to cooperate and deliver needed science.

Science is defined by characteristics that make it a distinctive form of knowledge: one that is systematically organised and is rationally explicable, tested against reality, and the scrutiny of peers. Knowledge claims are tested against logic and reality. As a result, science is self-correcting and evolves.

Why does this matter? **Science, even with its distinctive characteristics, does not exist in isolation from other knowledge systems** be they originating from religion, local or indigenous knowledge, or the tacit knowledge of different occupations including politics. But to be useful it must live respectively and hopefully in dialogue with them. Ensuring science can contribute to the public good depends on its integrity and on whether it provides relevant answers to real – if perhaps wicked – problems. This also demands that **science does not claim that it can answer everything or make decisions on behalf of society.** It is society, not science that should determine the use of science and technology.

But the way science systems are organised within a society is influenced by culture, history, and context. There are enormous differences across the globe in how science is organised and used. It is thus possible to talk about decolonising science systems without threatening the principles that define science. It is critical for effective multilateral science cooperation that we understand these variations in science systems despite the universality of science. Science cooperation may fail when global north scientists operating in distant contexts fail to recognise these differences...

Overall, Sir Peter addressed the following key points:

 ISC's Strategic Priorities: The ISC focuses on enhancing science's role in decision-making, promoting scientific freedom, and fostering international cooperation, while emphasizing the critical distinction between science and science systems amidst global challenges.

- **Unique Nature of Science:** Sir Peter highlights that science is as a systematically organized, empirically tested, and evolving form of knowledge that must engage with other knowledge systems to contribute to the public good effectively
- **Decolonizing Science Systems**: Acknowledging and respecting the diversity in global science organization and usage is essential for effective international cooperation and addressing the decolonization of science systems without compromising scientific principles.
- Addressing Science Production and Trust Challenges: The speech highlights the importance of disciplinary research (mode 1) but also advocates transdisciplinary, stakeholder-involved approaches (mode 2) to better address complex global issues, alongside a commitment to launching a pilot funding scheme to support this research.
- **Evolving Science for Global Challenges:** An evolution in the science system is called for, balancing traditional research with transdisciplinary approaches to foster international cooperation and address global challenges, highlighting the role of science in supporting multilateral diplomacy

# High life satisfaction reported among small-scale societies with low incomes

It is often said that money can't buy happiness, yet many surveys have shown that richer people tend to report being more satisfied with their lives. This tendency could be taken to indicate that high material wealth—as measured in monetary terms—is a necessary ingredient for happiness. Here, we show survey results from people living in small-scale societies outside the globalized mainstream, many of whom identify as Indigenous. Despite having little monetary income, the respondents frequently report being very satisfied with their lives, and some communities report satisfaction scores similar to the wealthiest countries. These **results imply greater flexibility in the means to achieve happiness** than are apparent from surveys that examine only industrialized societies.

# Abstract

Global polls have shown that people in high-income countries generally report being more satisfied with their lives than people in low-income countries. The persistence of this correlation, and its similarity to correlations between income and life satisfaction within countries, could lead to the impression that high levels of life satisfaction can only be achieved in wealthy societies. However, global polls have typically overlooked small-scale, nonindustrialized societies, which can provide an alternative test of the consistency of this relationship. Here, we present results from a survey of 2,966 members of Indigenous Peoples and local communities among 19 globally distributed sites. We find that high average levels of life satisfaction, comparable to those of wealthy countries, are reported for numerous populations that have very low monetary incomes. Our results are consistent with the notion that human societies can support very satisfying lives for their members without necessarily requiring high degrees of monetary wealth.

# **TRIPS Council finalizes preparations for MC13**

13 February 2024

At a meeting of the Council for Trade-Related Aspects of Intellectual Property Rights (TRIPS) on 13 February, WTO members adopted two reports that the Council Chair, Ambassador Pimchanok Pitfield of Thailand, had developed to complete work in Geneva as much as possible before ministers gather in Abu Dhabi on 26-29 February for the 13th WTO Ministerial Conference (MC13).

The reports address two issues the Council has been discussing since the 12th Ministerial Conference (MC12) in June 2022: whether to extend the Ministerial Decision on the TRIPS Agreement (<u>WT/L/1141</u>) to COVID-19 therapeutics and diagnostics, and the Council's current and future work under paragraphs 23-24 of the Ministerial Declaration on the WTO Response to the COVID-19 Pandemic and Preparedness for Future Pandemics (<u>WT/L/1142</u>).

The first report summarizes discussions held since 2022 and recognizes the considerable efforts members have made to support a fact- and evidence-based discussion on paragraph 8 of the MC12 Decision on the TRIPS Agreement regarding its possible extension to cover COVID-19 diagnostics and therapeutics. It also acknowledges that despite these efforts, consensus could not be reached on the extension of the Decision.

The second report notes that the Council for TRIPS will continue its work as directed by the Ministerial Declaration from MC12 to review and build on all the lessons learned and the challenges experienced during the COVID-19 pandemic, and to build effective solutions in case of future pandemics, in an expeditious manner.

The role of intellectual property, and more specifically voluntary licensing, technology transfer, the operation of the Medicines Patent Pool (MPP), geographical limitations of licences and the operation of Article 31(f) of the TRIPS Agreement were noted as areas of interest to members in that context...

**Research snapshot: Improving access to safe abortion in humanitarian settings** 16/02/2024

Access to safe abortion is a recognised human right– but humanitarian agencies often fail to offer this essential health service. Refugees and displaced people face uniquely challenging barriers to abortion access. This mixed-methods community-engaged study found that most women and girls in Kakuma Refugee Camp (Kenya) and Bidibidi Refugee Settlement (Uganda) did not use World Health Organization recommended abortion methods. Instead, traditional herbs, non-medication abortion pharmaceutical drugs, or other unsafe methods were used. Very few reported using medication abortion or obtaining an abortion in a health care facility.

The study recommends that more resources should be dedicated to improving provision of safe abortion in humanitarian settings, including self-managed medication abortion, which has been demonstrated to be an effective, safe, and high quality experience in other settings where access to abortion in the formal healthcare system is limited.

This snapshot contains key messages, findings, implications for humanitarian policymakers and practitioners and recommendations for further research.

## Health Ecology and Disease Transmission

About 75% of emerging infectious diseases are now zoonotic, with continued climate change expected to exacerbate transmission in environments shared among plants, human animals, and domestic, agricultural, and wild nonhuman animals. One Health is an approach that promotes national and international collaboration and coordinated responses to human population growth, agricultural encroachment and deforestation, ecosystem disruption, and interactions that intensify human-nonhuman animal transmission risks. Our results show that the extension of mobile phone use significantly contributes to the improvement of early child health in Africa. This effect is indifferent to the state or the level of democracy. Also, the internet diffusion plays a positive role in early child health

when the democracy environment improves and becomes better. We suggest policies in favour of a large access to ICT tools and internet infrastructure as well as the promotion of democracy in Africa to better prevent infant mortality.

Dengue, caused by four closely related viruses, is a growing global public health concern, with outbreaks capable of overwhelming health-care systems and disrupting economies. Dengue is endemic in more than 100 countries across tropical and subtropical regions worldwide, and the expanding range of the mosquito vector, affected in part by climate change, increases risk in new areas such as Spain, Portugal, and the southern USA, while emerging evidence points to silent epidemics in Africa. Substantial advances in our understanding of the virus, immune responses, and disease progression have been made within the past decade. Novel interventions have emerged, including partially effective vaccines and innovative mosquito control strategies, although a reliable immune correlate of protection remains a challenge for the assessment of vaccines. These developments mark the beginning of a new era in dengue prevention and control, offering promise in addressing this pressing global health issue.

#### A vote for childhood NTD elimination

The Lancet Child & Adolescent Health

At least 1.2 billion children and adolescents (<25 years)—one in six globally—are affected by one or more neglected tropical diseases (NTDs). As a group of common infections with relatively cheap treatments, NTDs are precipitated by extreme poverty and perpetuated through political neglect. For children there are added challenges in avoiding infection and accessing safe medicines. NTD elimination efforts have withstood years of tumultuous global dynamics marked by escalating conflict and climate disasters, and local actors have overcome seemingly insurmountable challenges. Yet, with root causes in some of the most divisive election topics—poverty, inequality, marginalisation, and climate—NTD partners and programmes could emerge jeopardised or strengthened in 2024, as people in at least 60 countries go to the polls...

Even in worst-case scenarios for 2024, NTD elimination efforts only stand to benefit from a childcentred and equity-focused dismantling of the systemic obstacles to treating and eliminating NTDs. In this vein, a growing body of evidence shows the potential of health-promoting schools to bring together children in a clean and safe environment where they can receive deworming, vaccines, and health checks in tandem with health literacy education and nutritious meals. A key research priority is advancing coverage beyond schools to reach those who are too young or poor for school. The future is uncertain, but advocacy, collaboration, and resource mobilisation will ensure childhood NTD partners and programmes triumph.

Incorporating parental values in complex paediatric and perinatal decisions

#### Summary

Incorporating parental values in complex medical decisions for young children is important but challenging. In this Review, we explore what it means to incorporate parental values in complex paediatric and perinatal decisions. We provide a narrative overview of the paediatric, ethics, and medical decision-making literature, focusing on value-based and ethically complex decisions for children who are too young to express their own preferences. We explain key concepts and definitions, discuss paediatric-specific features, reflect on challenges in learning and expressing values for both parents and health-care providers, and provide recommendations for clinical practice. Decisional values are informed by global and external values and could relate to the child, the parents, and the whole family. These values should inform preferences and assure value-congruent choices. Additionally, parents might hold various meta values on the process of decision making itself. Complex decisions for young children are emotionally taxing, ethically difficult, and often surrounded by uncertainty. These contextual factors make it more likely that values and preferences are initially absent or unstable and need to be constructed or stabilised. Health-care professionals and parents should work together to construct and clarify values and incorporate them into personalised decisions for the child. An open communication style, with unbiased and tailored information in a supportive environment, is helpful. Dedicated training in communication and shared decision making could help to improve the incorporation of parental values in complex decisions for young children.

#### A new dawn for malaria prevention

... The availability of R21/Matrix-M should complement RTS, S/AS01 and guarantee vaccination is available for all those in need at the global level. Children eligible for R21/Matrix-M are between 5 months and 3 years old. About 80 million eligible children live in malaria-endemic regions of sub-Saharan Africa. 240 million doses are needed to give them all three doses of the vaccines in 2024, followed by a further 80 million boosters in 2025. After that, including currently unvaccinated children, the roughly 30 million children born every year would need 120 million doses. This would save about 450 000 lives a year.

Now the deployment of both vaccines in the field opens new questions: should a booster be given each year to children until they reach school age? How easily can malaria vaccination be added to the complex immunisation schedule already in place for children in malaria-endemic countries? In the current landscape of highly localised malaria transmission, with spots of high and low malaria prevalence found in the same country, as seen in Tanzania or Kenya, will vaccination remain costeffective? Still, it seems the day when all children at risk of malaria can be offered a vaccine has arrived, and we cherish the work of all those who have paved the way to this historical achievement.

While anticipating the development of a COVID-19-specific vaccine several randomized controlled trials (RCTs) explored the potential of BCG vaccination to protect against COVID-19, based on trials demonstrating beneficial effects of BCG vaccination on unrelated infections and all-cause mortality in neonates in high-mortality geographical settings. Results are now available from 12 RCTs, which suggest that BCG vaccination is not an effective intervention against COVID-19. That the BCG–COVID-19 trials failed to meet expectation emphasizes the importance of rigorous clinical trials to validate hypotheses, even in urgent situations such as a pandemic.

The predominant research publishing system is not equitable by design, nor optimised to advance research to create knowledge and ultimately to benefit society. Open Research Central (ORC) was created to foster the re-imagination of the research dissemination system to facilitate trust, transparency and equitable participation. In five years of operation, before dissolving, the non-profit organisation produced outputs and learnings valuable to the development of a responsible research dissemination system. We are sharing our experience in the hope that it will provide others who share the same vision and goals with useful materials to build on. We think that there remains a need for global, cross-stakeholder exploration to build collective understanding of research validation and dissemination and to pilot solutions. However, as this article will explore, enabling and supporting the development of such a collective voice and consequent action is a challenging endeavour in the current landscape and funding environment.

# Open Research Central principles Below are five core principles that underpin the responsible dissemination of original research. Image: Colspan="2">Equitable participation in research communication Platforms, policies and practices should be designed to enable inclusive and diverse collaboration in research and its dissemination. Image: Colspan="2">Rapid access to research Research outputs should be made openly accessible as quickly and broadly as possible, and in the case of research articles, no later than the date of publication.



#### Transparent and accountable processes

Policies and practices should support research integrity and establish trust in the research and in the way it is disseminated.



#### Maximise reuse of research outputs

Researchers should be supported by community standards and policies to enable the widest possible reuse of research outputs.

Value all research outputs and processes across the research lifecycle All components of a research project should be shared and acknowledged through appropriate credit.
