Rich countries attain record human development, but half of the poorest have gone backwards, finds UN Development Programme

Rising political polarization and distrust results in gridlock on global challenges March 12, 2024

New York - Uneven development progress is leaving the poorest behind, exacerbating inequality, and stoking political polarization on a global scale. The result is a dangerous gridlock that must be urgently tackled through collective action, according to a new report released today by the United Nations Development Programme (UNDP).

The 2023/24 Human Development Report (HDR), titled Breaking the Gridlock: Reimagining cooperation in a polarized world, reveals a troubling trend: the rebound in the global Human Development Index (HDI) – a summary measure reflecting a country's Gross National Income (GNI) per capita, education, and life expectancy – has been partial, incomplete, and unequal.


The HDI is projected to reach record highs in 2023 after steep declines during 2020 and 2021. But this progress is deeply uneven. Rich countries are experiencing record-high levels of human development while half of the world's poorest countries remain below their pre-crisis level of progress.

Global inequalities are compounded by substantial economic concentration. As referenced in the report, almost 40 percent of global trade in goods is concentrated in three or fewer countries; and in 2021 the market capitalization of each of the three largest tech companies in the world surpassed the Gross Domestic Product (GDP) of more than 90 percent of countries that year.

"The widening human development gap revealed by the report shows that the two-decade trend of steadily reducing inequalities between wealthy and poor nations is now in reverse. Despite our deeply interconnected global societies, we are falling short. We must leverage our interdependence as well as our capacities to address our shared and existential challenges and ensure people's aspirations are met," said Achim Steiner, head of the UN Development Programme. "This gridlock carries a significant human toll. The failure of collective action to advance action on climate change, digitalization or poverty and inequality not only hinders human development but also worsens polarization and further erodes trust in people and institutions worldwide."


The report argues that advancing international collective action is hindered by an emerging 'democracy paradox': while 9 in 10 people worldwide endorse democracy, over half of global survey respondents express support for leaders that may undermine it by bypassing fundamental rules of the democratic process, as per data analysed in the report. Half of people surveyed worldwide report having no or limited control over their lives, and over two-thirds believe they have little influence on their government's decisions.

**Political polarization is also a growing concern with global repercussions.** Along with a sense of powerlessness, report authors say, it is fuelling inward-turning policy approaches – starkly at odds with the global cooperation needed to address urgent issues like the decarbonization of our economies, misuse of digital technologies, and conflict. This is particularly alarming in light of 2023's recordbreaking temperatures, which emphasize the immediate need for united action to tackle the climate crisis, or in the advent of artificial intelligence as a new and fast-evolving technological frontier with little or no regulatory guard rails.

The report highlights that deglobalization is neither feasible nor realistic in today's world and that economic interdependence remains high. It points out that no region is close to self-sufficiency, as all rely on imports from other regions of 25 percent or more of at least one major type of goods and services.

"In a world marked by increasing polarization and division, neglecting to invest in each other poses a serious threat to our wellbeing and security. Protectionist approaches cannot address the complex, interconnected challenges we face, including pandemic prevention, climate change, and digital regulation," Steiner added. "Our problems are intertwined, requiring equally interconnected solutions. By adopting an opportunity-driven agenda that emphasizes the benefits of the energy transition and of artificial intelligence for human development, we have a chance to break through the current deadlock and reignite a commitment to a shared future."

# The report emphasizes how global interdependence is being reconfigured and calls for a new generation of global public goods. It proposes four areas for immediate action:

- planetary public goods, for climate stability, as we confront the unprecedented challenges of the Anthropocene;
- digital global public goods, for greater equity in harnessing new technologies for equitable human development;
- new and expanded financial mechanisms, including a novel track in international cooperation that complements humanitarian assistance and traditional development aid to low-income countries; and
- dialling down political polarization through new governance approaches focused on enhancing people's voices in deliberation and tackling misinformation.

In this context, multilateralism plays a fundamental role, the report argues, because bilateral engagements are not able to address the irreducibly planetary nature of the provision of global public goods.

## More key data from the report

- In 2023, all 38 countries that are members of the Organization for Economic Co-operation and Development (OECD) achieved higher Human Development Index (HDI) scores compared to their levels in 2019.
- Among the 35 least developed countries (LDCs) that experienced a decline in their HDI in 2020 and/or 2021, more than half (18 countries) have not yet recovered to their human development levels of 2019.
- All developing regions have not met their anticipated HDI levels based on the trend before 2019. It
  appears they have shifted to a lower HDI trajectory, indicating potential permanent setbacks in
  future human development progress.
- The impact of human development losses is in sharp focus in Afghanistan and Ukraine.
   Afghanistan's HDI has been knocked back by a staggering ten years, while Ukraine's HDI dropped to its lowest level since 2004.

The report cites research indicating that countries with populist governments have lower GDP-growth rates. Fifteen years after a populist government assumes office, the GDP per capita is found to be 10 percent lower than it might under a non-populist government scenario.

<u>Convention on Certain Conventional Weapons — Group of Governmental Experts on Lethal Autonomous Weapons Systems</u>

#### Overview

The 2023 Meeting of the High Contracting Parties to the Convention on Certain Conventional Weapons (CCW) decided to organize "the Group of Governmental Experts of the High Contracting Parties related to emerging technologies in the area of lethal autonomous weapons systems (LAWS), for a duration of 10 days, from 4 to 8 March 2024 and from 26 to 30 August 2024" (CCW/MSP/2023/7, paragraph 24 (c)). The Meeting also adopted the relevant cost estimates for 2024 as contained in CCW/MSP/2023/5.

The 2023 Meeting of the High Contracting Parties to the CCW also decided "That the work of the open-ended Group of Governmental Experts related to emerging technologies in the area of lethal autonomous weapon systems established by Decision 1 of the Fifth Review Conference as contained in document CCW/CONF.V/10, adhering to the agreed recommendations contained in document CCW/CONF.V/2, is to continue, to strengthen the Convention. In the context of the objectives and purpose of the Convention, **the Group is to further consider and formulate, by consensus, a set of elements of an instrument, without prejudging its nature, and other possible measures to address emerging technologies in the area of lethal autonomous weapon systems, taking into account the example of existing Protocols within the Convention, proposals presented by High Contracting Parties and other options related to the normative and operational framework on emerging technologies in the area of lethal autonomous weapon systems, building upon the recommendations and conclusions of the Group, and bringing in expertise on legal, military, and technological aspects." Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects as amended on 21 December 2001, usually referred to as the Convention on Certain Conventional Weapons or CCW, is a key international humanitarian law instrument. It was adopted on 10 October 1980 and entered into force in 1983.

The purpose of the Convention is to ban or restrict the use of specific types of weapons that are considered to cause unnecessary or unjustifiable suffering to combatants or to affect civilians indiscriminately.

## **Levels and trends in child mortality: Report 2023**

United Nations Inter-Agency Group for Child Mortality Estimation (UN IGME) March 12, 2024

This year's United Nations Inter-agency Group for Child Mortality Estimation (UN IGME)'s findings represent a noteworthy moment in the ongoing campaign to end all preventable child deaths: The annual number of under-five deaths has fallen to 4.9 (4.6–5.4) million in 2022.

The report reveals that more children are surviving today than ever before, with the global under-5 mortality rate declining by 51 per cent since 2000. And several low- and lower-middle-income countries have outpaced this decline. This is a testament to the commitment of governments, organizations, local communities, health-care professionals and families to the survival of the most vulnerable members of our global community.

**Yet millions of children still died before seeing their fifth birthday** – a loss that serves as a crucial reminder that threats to newborn and child health and survival persist around the world, particularly among the most marginalized children. In addition to the 4.9 million lives lost before the age of 5 – nearly half of which were newborns – the lives of another 2.1 million children and youth aged 5-24 were also cut short. **Most of these deaths were concentrated in sub-Saharan Africa and Southern Asia**. There is still a long road ahead to end all preventable child and youth deaths.

**Ending preventable child deaths in every community will require targeted investments in available, accessible quality health care,** including skilled health personnel at birth, antenatal and postnatal care, care for small and sick newborns, **preventive services such as vaccination**, and diagnostic, preventive and curative measures to treat the key causes of childhood death. Data systems must also be strengthened to track and monitor survival by age and to help address underlying inequalities. This will enable us to move closer to achieving the Sustainable Development Goals and ensure that every child has the opportunity to thrive.

# Ninth meeting of the Intergovernmental Negotiating Body (INB) for a WHO instrument on pandemic prevention, preparedness and response

#### 18 - 28 March 2024

09:00-12:00, 13:00-16:00 and 16:30-18:30 CET, Geneva, Switzerland

In December 2021, the World Health Assembly established an <u>Intergovernmental Negotiating Body</u> (INB) to draft and negotiate a convention, agreement or other international instrument under the Constitution of the World Health Organization to strengthen pandemic prevention, preparedness and response.

The ninth meeting of the INB is to be held in hybrid format from 18 to 28 March 2024. At INB8, Member States requested the INB Bureau, formed by six officers, one from each of the six WHO regions, to develop a revised draft of the negotiating text of the WHO Pandemic Agreement. This draft will be the basis of textual negotiations at INB9.

The opening and closing plenary sessions of the INB are open to WHO Member States, Associate Members, Observers and regional economic integration organizations, as well all relevant stakeholders.

These sessions will be publicly webcast and archived for later viewing. Substantive negotiating sessions will be held in closed format.

<u>Situation of human rights in Myanmar - Report of the Special Rapporteur on the situation of human rights in Myanmar, Thomas H. Andrews - Advance unedited version</u>

Thematic reports 14 March 2024

A/HRC/55/65: Myanmar

Summary

The human rights and humanitarian crisis precipitated by the 2021 military coup has continued to worsen in Myanmar. The military junta has responded to mounting losses of troops and territory by escalating its aerial attacks on villages, blocking humanitarian aid, and announcing plans to draft thousands of young people into the military. Many have gone into hiding, fled the country, or joined resistance forces.

The people of Myanmar have responded with courage, resolve, and defiance. Armed resistance forces are steadily gaining ground, securing territory as they hand junta forces stunning losses. **Civil Disobedience Movement health care workers are working tirelessly to serve those in need even as clinics and hospitals are attacked.** "Citizen sanctions" persist as people refuse to purchase goods or services that are linked to the junta. Silent strikes and "pop-up" protests demonstrate defiance and encourage a weary population.

Many in Myanmar express deep disappointment in the international community's response to the crisis. They are frustrated by the failure of the UN Security Council to act and see clear signals that Myanmar lacks significance to UN and world leaders, their rhetoric notwithstanding.

In this report, the Special Rapporteur identifies opportunities for the international community to support the people of Myanmar. Member States should strengthen coordinated action to deprive a weakened junta of weapons, money, and legitimacy, take steps to ensure accountability for the perpetrators of atrocity crimes, and support the efforts of leaders forging a political framework for a just, peaceful, and democratic Myanmar. **Donors and humanitarian organizations must ensure that desperately needed humanitarian aid reaches those with the greatest needs, including displaced populations in conflict areas.** 

The Special Rapporteur urges the international community to seize these opportunities.

#### X. Recommendations

- 118. The Special Rapporteur **calls on the military junta to immediately end attacks on civilians and other human rights violations, halt the use of cluster munitions**, release all political prisoners, dissolve the State Administration Council, stand down so that a legitimate government reflecting the will of the people can be formed, and cooperate with international accountability mechanisms.
- 119. The Special Rapporteur calls on all parties to armed conflict in Myanmar to **halt the use of anti- personnel landmines.**
- 120. The Special Rapporteur calls on the UN Security Council to pass a resolution that (i) imposes a comprehensive arms embargo on Myanmar, including on transfers of jet fuel and other dual-use technologies to the military; (ii) imposes targeted economic sanctions on the SAC, its leaders, and its sources of revenue, and (iii) refers the situation in Myanmar to the International Criminal Court.
- 121. In order to promote future peace, stability, and respect for human rights in Myanmar, the Special Rapporteur **urges Member States, UN agencies, international donors, and international humanitarian organizations to**:
  - (a) **Recognize the National Unity Government** as the legitimate representative of the people of Myanmar;
  - (b) Formally and publicly engage the National Unity Government, National Unity Consultative Council, ethnic resistance organizations, and Myanmar civil society leaders; and
  - (c) Provide the National Unity Government, National Unity Consultative Council, ethnic resistance organizations, and Myanmar civil society with financial, technical, and diplomatic support, including support to enhance dialogue between themselves and to advance the political framework for a future peaceful and democratic Myanmar.
- 122. To end impunity and ensure accountability for international crimes committed in Myanmar, **the Special Rapporteur urges Member States to:** 
  - (a) **Refer the situation in Myanmar to the Prosecutor of the International Criminal Court** under Article 14 of the Rome Statute, requesting an investigation into alleged crimes that have been committed against the people of Myanmar; and
  - (b) Support other efforts to hold perpetrators of atrocity crimes accountable in impartial and independent courts, including the International Criminal Court, the International Court of Justice, and national courts in countries with universal jurisdiction laws;...

The need for effective intervention could not be more urgent. Today more than 15 million children are out of school in the Middle East region due to conflict and crisis. In Gaza, around 1.7 million people are estimated to have been internally displaced – half of them children. These children need quality early childhood support and they need it now."

#### <u>ICOMOS Indigenous Heritage Working Group – Call for members</u>

International Council on Monuments and Sites (ICOMOS) 06 March 2024

Following the unanimous approval of a resolution to develop practices to better understand and conserve indigenous cultural heritage by the ICOMOS General Assembly in Delhi in December 2017, an ad hoc committee of members from various ICOMOS National Committees and International Scientific Committees initiated the steps leading to the creation of the ICOMOS Indigenous Heritage Working Group (IHWG). The Working Group is now launching a call for members.

The overall aim of the Indigenous Heritage Working Group (IHWG) is to serve as an ICOMOS international platform for indigenous heritage leaders together with non-indigenous practitioners to identify and develop the knowledge, understanding and conservation of indigenous cultural heritage.

The mandate of the working group is specifically about **delivering outcomes for Indigenous heritage and is not about managing or speaking on behalf of Indigenous people**. The work of the IHWG is a critical aspect of ICOMOS' ability to meet its mandate of providing guidance on the conservation of cultural heritage and on supporting the implementation of the World Heritage Convention.

With this in mind, Expressions of Interest are now called for Indigenous members of ICOMOS who would like to join the IHWG and non-indigenous members for are highly skilled and /or experienced in working in the field of Indigenous heritage (noting the caveat above that preference will be given to Indigenous members)...

**The IHWG has adopted the understanding of Indigenous people** as articulated by the United Nations. Specifically this is based on:

- Self-identification as indigenous peoples at the individual level and accepted by the community as their member.
- Historical continuity with pre-colonial and/or pre-settler societies
- Strong link to territories and surrounding natural resources
- Distinct social, economic or political systems
- Distinct language, culture and beliefs
- Form non-dominant groups of society
- Resolve to maintain and reproduce their ancestral environments and systems as distinctive peoples and communities...

ICOMOS, the International Council on Monuments and Sites, is a global non-governmental organization associated with UNESCO. Its mission is to promote the conservation, protection, use and enhancement of monuments, building complexes and sites. # <u>Director General's Statement on the European Union Corporate Sustainability Due</u> Diligence Directive

UNIDO - United Nations Industrial Development

15 March - The European Union's Committee of Permanent Representatives of the Governments of the Member States has come to provisional agreement regarding the proposed **Corporate Sustainability Due Diligence Directive (CSDDD).** With the vote in favour of adopting the Directive after lengthy negotiations, the European Union will move to introduce a duty on corporations to see to the maintenance of human rights and environmental standards in their global supply chains.

UNIDO Director General Gerd Müller greeted the CSDDD agreement, stating: "Today, the EU has set the course for fairer and more equitable globalization. Millions of workers in developing countries will benefit from this Directive. Internationally operating European companies will now have to comply with fundamental international social and environmental standards such as the ban on child labor or the contamination of drinking water. This is urgently necessary: roughly 80 million children are engaged in the worst forms of child labour - including for products which are sold and consumed in Europe. From now on, Europe will show that European products stand for human rights and fair production. Exploitation and child labour in developing countries must no longer be a competitive advantage!

This is a summary of what was said by Antonella d'Aprile, WFP Country Director in Mozambique to whom quoted text may be attributed - at today's press briefing at the Palais des Nations in Geneva.

Geneva – This week marks five years since Cyclone Idai struck, affecting more than 2 million people across Mozambique, Malawi and Zimbabwe. In fact, on March 12 in the night, Tropical Storm Filippo entered southern Mozambique, Inhassoro district in Inhambane province, with a very strong winds of up to 120 kilometers per hour. It exited back into the Mozambique channel on March 13th through Gaza province. # AI's economic peril to democracy

Artificial Intelligence Stephanie A. Bell, Anton Korinek March 14, 2024

Artificial intelligence (AI) is poised to fundamentally reshape labor markets and the economy. If the gains accrue narrowly while human labor loses value, economic inequality could substantially worsen. In our recent article on "AI's Economic Peril" for the *Journal of Democracy*, we argue that this poses a grave threat to democracy that is separate from more traditional AI risks to democracy such as deep fakes and misinformation: High inequality corrodes democratic institutions through increased elite

# Rockefeller Foundation Calls for Boosting Underutilized Crops To Strengthen Africa's Food and Nutrition Security

New research builds evidence base for investing in wider array of crops across the continent to support climate resilience and nutrition

NEW YORK | March 14, 2024 — The Rockefeller Foundation today released <u>two reports</u> that build the evidence base for investing in underutilized indigenous and traditional crops as a means of strengthening food and nutrition security and climate resilience in Africa. In collaboration with Agricultural Model Intercomparison and Improvement Project (AgMIP) and Havos.ai, the reports include actionable recommendations to boost agricultural productivity and nutrition and advance the Vision for Adapted Crops and Soils (or "VACS"), a partnership between the African Union (AU), Food and Agricultural Organization of the United Nations (FAO), and the Office of the Special Envoy for Food Security at the U.S. State Department. The field of Public Health Genomics recently celebrated its twenty-fifth anniversary [1]. Defined by the CDC as responsible and effective translation of genome-based knowledge and technologies for the benefit of population health, public health genomics applications have expanded beyond newborn screening to other applications poised to improve public health [2, 3]. Yet despite the promise and potential for public health genomics, the population health impact and sustainability of public health genomics applications has yet to be fully measured and achieved. Further access to public health genomics applications has been lower among underrepresented racial and ethnic communities, rural communities, and groups with lower education and income [2], deepening concerns that the field could exacerbate rather than redress health inequities [4, 5]. As we enter the next generation of public health genomics, we must shift our focus from not only understanding the collection of genetic risk information and related needs, but also the real-world use of this precision information and its impact on population health outcomes and health equity over time...


